FIGHTING OLD BATTLES.

MORE CRITICISM OF BRITISH POLICY IN SOUTH AFRICA.

MORALITY PLAYS AT CHARTER HOUSE-THE VICTORY OF SHAMROCK II.

London, July 14, 1 a. m .- The war in South africa cannot be finished by fighting the battle of Vlakfontein over again day after day in the

Lieutenant Hern, who was expected to make important disclosures on his arrival from the Cape, has disappointed the critics, for he has shown himself a discreet officer, and not a garrulous marplot. His statement that he made a full report to a member of Lord Kitchener's staff respecting the incidents witnessed by him at Vlakfontein serves to convince the War Office that the general in command had good reasons for not exaggerating the importance of the charges of atrocity.

The military journals are finding fault with the British methods of waging war as absurdly and mischievously flabby, and are asserting that it is almost ludicrous that Lord Kitchener should feed refugees and women and children, and thereby relieve the Boers from the urgent necessity of surrendering in order to support their families. They forget that the clearance of the Dutch territories would have resembled the Spanish operations in Cuba if the families had been rooted up from farms and left to perish from starvation.

The main point is whether Lord Kitchener, without being inhumane, is succeeding in emptying and exhausting the Boer districts, and is wearing out the resources of guerilla warfare by constant hammering.

Evidence that the clearance of the large districts has been thorough, and that the British operations have not been impaired by sentimental considerations, is direct and conclusive. Lord Kitchener is doing his work in his own way and on set lines, but is not repeating Spanish methods in starving women and children.

There was a remarkable dramatic performance yesterday in the quadrangle of the old Charter House, sacred to the memory of Thackersy and Colonel Newcome. This was the open air production of the two oldest Morality plays in English literature. One was entitled "Every Man," and was based on a text found in the Hirary of Lincoln Cathedral, and the other was a passage from "The Sacrifice of Isaac," taken from one of the Chester series of Miracle plays. These Morality plays were staged with simplicity, costumed from early XVth century tapestries and from Holman Hunt's Oriental collection, and enacted with dignity and force under the direction of Wiliam Poel, the manager of the Elizabethan Stage Society. About twenty characters were impersonated in the two plays, and the lines were recited with clearness and fervor. A large audience witnessed this unique entertainment on the site of the old Carthusian Monastery, and was impressed with the dramatic force of these mediæval dramas, designed originally by the monks for religious and didactic teaching, but marking a humble beginning of English literature in the theatre.



AT LEAST FIFTY PERSONS IN PRINCE CHUNG'S PARTY.

Washington, July 13.-On Minister Wu will fall the responsibility for the entertainment of no less than fifty persons connected with the Chinese imperial mission which has just started for Germany to express regret for the killing of Baron von Ketteler, the German Minister, in Peking last year. Prince Chung, the head of the mission, will return to China from Europe by way of the United States, and while in Washington will be the guest of the resident minister, with a staff outnumbering by far that which accompanied Li Hung Chang on his tour around the world.

RUSSIAN MONUMENT AT TIEN-TSIN. Tien-Tsin, July 13 .- A hundred Russian of-

WIDOW ENTITLED TO DOWER RIGHTS.

DECISION ON CONSTRUCTION TO BE APPLIED TO WILL OF A WEALTHY BREWER.

Justice Bischoff in the Supreme Court yester for the construction of the will of Conrad Stein, the brewer, who died on April 6, 1900, leaving an estate valued at \$5,000,000. The action was brought by Dr. Emil Heuel, a son-in-law of the testator and one of the executors of his will, in order that certain clauses in the instrument relative to the provision made for Mrs. Stein and her children

might be passed on.

Prior to his death Stein purchased the home at No. 327 West Fifty-seventh-st. in his wife's name He left her the furniture, statuary, bric-a-brac, pictures, and horses and carriages owned by him, together with the contents of a safe in the house. ties worth \$400,000.

To his sons Conrad and Alexander he left the brewery, at Tenth-ave, and Fifty-seventh-st., and property and moneys in the Germania and West property and moneys in the Germania and West Side banks, on the condition that they pay their mother \$20 a week during her lifetime. He said he made no further provision for his widow, as he was aware that she was entitled to her right of dower in his estate. The residue of his property, after making some other bequests, was left hetween his seven children, but none of it was to be distributed until the youngest came of age.

Justice Bischoff decides that Mrs. Stein is entitled to dower in all the real estate left by her husband, notwithstanding the provisions made for her by the will. He also holds that the provision tying up the residue until the youngest child comes of age is valid. These were the chief points in dispute.

THE WEATHER REPORT.

YESTERDAY'S RECORD AND TO-DAY'S FORECAST. Washington, July 13.-The hot wave continues in the West and South and in the Ohio Valley, although the maximum temperatures, as a rule, were not quite so high as on Friday. In Western Arkansas and the Lower Mississippi Valley, however, it was slightly warmer, Fort Smith, Ark., reporting a maximum of 106 degrees, and New-Orleans 102 degrees, exceeding the high record of Friday by two degrees. In the East the temperatures have remained below the seasonal average, with rain in the South Atlantic States. In the interior of the country there was no rain of consequence. West of the Rocky Mountains the weather has continued generally fair withontinue in the central valleys, in the West and Southwest on Sunday, and most likely on Monday, except in the Northwest, where thunder showers will bring relief in the next thirty-six hours. In the lower lake region and the Middle Atlanti; States and New-England the temperatures will rise slowly after Sunday morning, but no extremes are at present indicated. There will be showers Sunday in the South Atlantic States, probably continuing Monday, and extending into the East Gul


