WOULDN'T LEND HER \$200,000

Mrs. Chadwick Falled to Get That Sum of a Boston Trust Company.

BOSTON, Dec. 6 .- Before Mrs. Cassie L. Chadwick negotiated the loan from Herbert B. Newton last spring she endeavored to borrow money from the International Trust Company of this city on the strength of the overworked \$500,000 note signed with the name Andrew Carnegie and the certificate of Iri Reynolds that she had \$5,000,000 in securities on deposit in the Wade Park Bank of Cleveland.

Mrs. Chadwick's application was rejected as soon as it was apparent that the only thing she had in sight was the note bearing the name of Mr. Carnegie. John M. Graham, president of the trust company, said to-day that he had an opportunity several months ago to consider the note cation for a loan was made by an attorney.

Last spring, Mr. Graham said, a Boston
lawyer representing Mrs. Chedwick, called
on the trust company and asked for a loan
of \$200,000.

"I asked him right off what he had for security," said Mr. Graham. "He told me the same story that Mrs. Chadwick appears to have told the other persons from whom she wished a loan, as I read of it. He exhibited the certificate to the effect that Mrs. Chadwick had securities to the amount \$5.000,000 on deposit in Cleveland, and also had that \$500,000 note of which there

has been so much talk. "Mr. Carnegie's name appeared on the note, but that did not make any impression on me. I spent no time at all considering his proposition. We did not discuss what

his proposition. We did not discuss what the woman wanted the money for because, as soon/as I saw what security he had to offer I told him that I could not consider making a loan. I said 'This is all too mysterious, too indefinite for me to consider.

"I did not place any confidence in the note of \$500,000 bearing a name like that of Andrew Carnegie, but if I had been told that the woman had \$1,250,000 of such notes, as is s'ated by the Cleveland banker. Dec. 6.—The resolutions recently adopted by the representatives of the zemstvos at their meeting in this city have been remitted to the Council of State for the purpose of a report. The Council consists, chiefly, in addition to the senior kinsmen of the Crar, of superannuated heads of departments. M. de Witte, ex-Minister of Finance, and Admiral Alexieff, ex-Vicerov of the Far East, are also members, they having been appointed to the Council after their removal from

active official life. The sending of the resolutions to the council is regarded as shelving the proposals, so far as early imperial action on them is concerned. The leaders of the zemstvos state that this action is in accordance with the course they expected would be pursued. They point to the fact that all kindred independent bodies are now proceeding to hold meetings to indorse

the zemstvos' resolutions. The leaders are much gratified by the appointment of M. Kutter as Assistant Minister of the Interior for the zemstvos by Prince Sviatapolk-Mirsky. M. Kutter is highly regarded for his public spirit when he was chief of the Department of Indirect Contributions under M. de Witte when the

latter was Minister of Finance. LONDON, Dec. 7 .- According to the St. Petershurg correspondent of the Telegraph the profound impression produced by the recent meeting of the zemstvos probably will be outdone by excitement when it becomes known that the highest assembly of the nobility of the Empire, meeting at Moscow, with Prince Troubetsky as presiding officer, refused by a large majority to sign a loval address to the Cara officing to sign a loyal address to the Czar offering to support his Majesty during the dire tribulations through which the fatherland is passing. Representatives of all the nobility were present. Prince Arsenies moved the address. Long and lively debates followed they being characterized by unsparing criticism of the present

regime.
It was finally resolved, instead of voting the address, to draw up a memorial plead-ing for the appointment of an assembly representing all classes of Russian society to devise the needful remedies for existing evils. This memorial is now being framed.

SHIPS AT PORT ARTHUR BAT-TERED BY THE JAPANESE.

the memory of the saint. M. Déroulède
telegraphed from his place of exile in Spain,
declaring that the Socialists were responsible for the attacks on Joan of Arc.

Jaurès was the most contemptible of her detractors. Jaurès challenged him. He was perfectly willing to fight (French rules), but a difficulty arose.
