## POLICE GO BACK TO BROOME ST

WA HEADQUARTERS WAS THERE 46 YEARS AGO.

Department Bureaus Are Moving Bit by Bit, and by Next Saturday Things Will Be Ripe for the Commissioner to Make an End of Old 300 Mulberry.

After an absence of forty-six years Police Headquarters is going back to Proome street. It was February 23, 1863, that the department moved from 413 Broome street to 300 Mulberry street, and now it is going back to almost the identirai spot from which it came, Broome and Centre streets. For the last week the moving has been under way. It is a delicate task, this moving of the executive office of a department comprising more than ten thousand men and doing it in such a way that its work will not be ham-

mu. At midnight Saturday night Commissioner Baker sent the first message the removal was officially recognized. Mulberry street will no longer be Police Headquarters.

This week the homicide bureau, the chief clerk's office, the bureau of information, the offices of the chief inspector and of the chief surgeon, the boiler inspection department, the detective bureau and the Deputy Commissioners, will be paraphernalia of their various departnents not absolutely necessary to transact their daily business.

They will not move one by one in any prearranged order, but each will go piecewell sending away first that part of its equipment which is least used. In this way they will be able to do business in the old offices almost up to the last minute. For several years the property clerk has been considerably embarrassed by lack of space. Its real organization began at 300 Mulberry under the oirection of Inspector Byrnes. Under him its efficiency grew, and the title "Central Office man" became an honor in the department and a word to inspire that in the hearts of the stoutest "gurs" all over the country. Inspector McCafferty, who is now in charge of the bureau is one of Byrness s men.

In the new headquarters the detective bureau will have more commodious quarters on the first floor. The rogues' gallery will be on the top floor with the photograph gallery. The rogues' gallery has been cramped for room for some time in the old detective bureau. There are

nas been cramped for room for some time in the old detective bureau. There are now 50,000 pictures in it. The record fles for criminals will also have room to grow. These files accumulate even faster than does the gallery, for every crook is listed, not only under his own name, but also under his various aliases, so one man many require six or eight cards.

For so long a time 300 Mulberry street has been a part of their lives that they will never fee, at home in the new quarters. The price of the lots was \$23,500. When the building was completed its entire cost was \$120,010. With the addition to the north end which was built six years later the cost was \$230,861.90. The new headquarters has been building for five years and its cost is about \$750,000.

At first the old Broadway squad was housed at 300 Multe-ry street, but it was crowded out in 1889. The old building has been through stormy times Less than six months after it was first occupied the July riots of 1863 broke out.

The new building is of granite with sarble triminings. It is topped by a lided dome which is visible for several blocks. The new crook's phrase will indoubtedly be "going under the dome."

The pension bureau, the trial room, the office of the chief clerk, the library and four record rooms will occupy the third floor. On the fourth floor will be draughtsmen, the training school, drill room, chief surgeon's office, running track, photograph storeroom, and two waiting rooms, one for chauffeurs and one for policemen on reserve. one for policemen on reserve.

The switchboard, complete and up to date, is on the top floor with the photograph gallery, the Bertillon room and the rogues' gallery. In the basement are storerooms for various departments, a shooting range, cells for the prisoners.

TELEPHONE CO. SOLD. Continental Gets Control of American Union of Pennsylvania.

HARRISBUR : Pa., Nov. 28 .- Control of virtually all the independent telephone lines in Pennsylvania outside of Phila delphia and Allegheny counties has passed into the hands of the Continental Tele phone and Telegraph Company of New Yers with the purchase of the American Union Telephone Company, which was announced at the headquarters of the American Union company here to-day The transaction was concluded in New York yesterday.

The American Union was formed for the purpose of continuing the independent lines in Pennsylvania about two years ago. Its authorized capital is \$25,000,000, of Its authorized capital is \$25,000,000, of which there has been issued \$2,900,000 of preferred and \$2,700,000 of common stock. It has \$11,000,000 of bonds outstanding. The officers are: President, John Graham of Newville, Pa.; vice-president, Charles West of Harrisburg; secretary and treasurer, S. R. Caldwell of Harrisburg.

The Continental Telephone and Telegraph Company controls independent lines in New York, New Jersey, Maryland, Deliware, Virginia and West Virginia. in addition to the Pennsylvania lines acquired by this latest purchase. It recently took over the Interstate Telephone Company of New Jersey.

PRISON REPORTS.

Rensselaer Jall in a Bad Way-Needs of Sing Sing.

ALBANY, Nov. 28.-George McLaugh lin, secretary, and Henry Solomon, inspector, of the State Prison Commission, have discovered that the Rensselaer county authorities play no favorites in making arrests. Everybody gets arrested in Rensselaer county. The county jail is in a bad way, the Prison Commission authorities point out in reports made public to-day. There is no eparation for male and female prisoners. No adequate provision is made for the women. They are even deprived of the sunlight and they are running amuck in the jail. There is no matron and the women are under the supervision of male

"According to the last report," says the Prison Commission's officials, "only about one-quarter of the persons committed to this jail were vagrants, and about two-thirds were laborers. The others were lawyers, carpenters, cooks, stonecutters, barbers, tailors, blacksmiths, painters, brushmakers, tinsmiths. wireworkers, second story workers, ironworkers, waiters, railroad men, machinists, boilermakers, steamfitters, linemen. agents, engineers, firemen, upholsterers, saloon keepers, farmers, shippers, candymakers, bakers, moulders, clerks, butchers, printers, dentists, weavers and

According to the report there has scarcely been a prosperous trade organization that the Rensselaer cops have overlooked.

The inspectors say that if the county jail is going to do such a wholesale and nighly representative business it ought to be kept in comfortable condition. Separate classes for men and women prisoners and a proper division of Rensselaer county's law violators while in jail, so that the less hardened criminals will not be contaminated, are also recom-Inspector Solomon inspected Sing Sing

The largest number of prisoners was in the spring of this year, when the register totalled 2,057. Mr. Solomon urges bet-ter educational facilities in the prison and recommends that instruction in grammer, telegraphy drawing and bedand recommends that instruction in grammer, telegraphy, drawing and book-keeping should be added to the curriculum. He thinks too that some instruction ought to be given the prisoners while they are at work; that certain parts of the day ought to be set aside in the shops for educational purposes.

Mr. Solcmon makes some severe criticism of conditions attending the care of unfortunate women. After an inspection of the New York State Reformatory for Women at Bedford, Mr. Solcmon concludes that there are too many young

tory for Women at Bedford, Mr. Solomon concludes that there are too many young women being detained at Blackwell's Island who ought to be at Bedford, "where they would have an opportunity to redeem themselves and again become self-respecting members of society." Mr. Solomon says this condition has been called to his attention.

"If such is the case," he adds, "it seems to me that more care should be taken by the courts, as the State having provided an institution for reformation it is a terrible thing to contemplate that they have not been allowed to avail themselves of it." He recommends legislation to improve the condition he criticises.

The possessor of the vibrant masculine voice was mollifled, reassured. "I'm giving it to you straight. She got the letter last night. It threatened all sorts of things and she's turned it over to the police. She's quite broken up about it—nervous, you know. Any body would get-but say, I think she might tell you something about it if you approached her in the right way. She's n now. Yeah, that's all I know. Goodby. Miss Zabelle answered a call on her telephone right away; that is, a feminine voice answered and said that it was Miss

Zabelle talking. "Why, what can you want to see about? I am just putting on my things to go out to dinner and I've no idea when -no really I do not think I will be back until late this evening; sorry but—
"Oh, that letter! Why, really, there

is no story in that for the newspapers. It's quite a private matter and one that I do not care to talk about; I-I would rather not talk about it, believe me. "Yes, it was from the Hunchakist

Society and it came addressed to me last night. I got one just like it three months ago and it made me very nerv-I say it made me very nervous. But, please do not wish to say anything more about "What? Oh, yes, I forgot to say that

t was written in Armenian. You know am an Armenian by birth, but I have not been there for many, many years. not been there for many, many years. So long ago that I have almost forgotten the language. I tried to translate a little of it and I got as far as \$5,000—it said they wanted me to give up \$5,000 like a loyal Armenian for the good of the cause. Yes, \$5,000 looks almost the same in Armenian as it does in English. But, please—

MRS. WILHELM TO BE TRIED. Charge of Murdering Her Husband Will Come Up in Newark To-morrow.

In the Court of Oyer and Terminer at Newark to-morrow morning Mrs. Mary J. Wilhelm will be placed on trial charged with the murder of her husband in their home, 448 High street, that city, last February. She was indicted for the murder jointly with Nicholas Sica, her lover, but he will not be tried until later.

Wilhelm, who was a real estate operator was found dead in the basement hallway of his home about 10 o'clock on the night of February 1. That afternoon Mrs. Wilhelm went out to visit friends in another part of the city. Just before she left the house, it is said, Sica called sne left the house, it is said, Sica called to talk about some business matters he had with Wilhelm. When Mrs. Wilhelm returned home she received no answer to her call for her husband and in search-ing through the house stumbled over his body. He was dead, having been shot in the head.

In their investigation the police learned that Sica and Mrs. Wilhelm had been friendly and he was arrested. About a month later the Grand Jury found an indictment against Mrs. Wilhelm and she was taken into custody. The information was given out that Wilhelm knew of the relation between his wife and Sica and that there was talk among the three of a divorce for the Wilhelms, so that Sica and the woman could get married.

Another leature in the case occurred while the burial services were being held over Wilhelm's body in the High street house. A woman appeared on the scene and after looking at the body told the detectives that the man was her husband, who deserted her and her children in New York twelve years ago. She said she had never been able to get any trace of him. The funeral was not interfered with, but the woman engaged counsel to look after her interests. Counsel for both women met later and agreed to a settlement of the affairs of Wilhelm. That was the last heard of the New York woman in the Case.

W. Harris. She was met at the pier by her father, Mr. Babcock of Detroit, who took her to the Hotel Prince George. At the pier she would not say whether or not there was a probability of a reconciliation between her husband

While the Touraine was nearing port on Saturday night the purser called out in the saloon that there was a wireless despatch for Mrs. Hunt. As she had registered as Mrs. Harris the purser naturally supposed that the message was not for Mrs. Harris. MAYBE SHE TELEKINETIZES

IF SO, THE PALADINO DOESN'T NEED JOHN'S HELP AT IT.

Dr. Hyslop Doesn't Find Proof of the Immortality of the Soul on the Surface When a Table Dances—So Viewless Gravitation Makes the Apple Fall.

Dr. James H. Hyslop talked about Eu-Fifty-seventh street. Dr. Hyslop said that too much fuss was being made over Eusapia, and he added that he couldn't see that there was any contravention of the laws of nature involved in the levitation of a table.

"I've no criticism to offer as to Eusapia Paladino," said Dr. Hyslop. "In my opinion she deserves careful investigation. I regard it as a good deal of a misfortune that she is popularly considered to accomplish her feats by conjuring. Eusapia Paladino is a hysteric. She is no fraud. and whatever she does when she in the so-called trance she is not responsible for. It is not my place to laugh at her or to doubt the honesty of her intentions.

"It strikes me that all the excitement which has been aroused over her is uncalled for. I cannot see that nature has been contravened. When I speak of excitement I don't mean solely popular excitement of the sort that you've doubtless observed among your associates, but the excitement among scientific men, who imagine that a new principle of nature has been discovered.

"One does not have to think very far to see three instances of motion the causation of which is at a distance from the object acted upon. One is magneanother is wireless telegraphy. and a third is gravitation. The par ticular form of motion which Eusapia Paladino appears to have exhibited has been known to psychologists for some time past. It is called telekinesis. The one thing over which we should be ex-ercised is the matter of evidence. Does Eusapia actually accomplish all that she appears to do? I take it that that is the chief point for scientific exami-nation."

Then Dr. Hyslop spoke of the laws which may underlie telekinesis of the sort which the Paladino apparently exhibits. He said that if one presupposes for the moment that Eusapia really does make tables move, such activity doesn't for a minute mean that "John" or any other spirit force is behind it. Before one can readily come to a conclu-Before one can readily come to a conclusion as to the causation of the phenomena one must, he said, be sure of the facts associated with the appearance of the

phenomena.

"I'm sorry," he said, "of all this talk about illusion and hallucination. It is possible that there may be instances of illusion and hallucination in the witnesses of Paladino's demonstrations, but I don't think we are prepared to conclude that such is the case."

If matters went on as they were doing, she said, the workers would lose their franchise because they had no money. The fight would come only when the masses realized that they were sure to win.
