Escaped at 11 o'clock. Took blind baggage for West Superior and reached destination on the morning of the 15th. Met a pal and with him visited his West Superior sweetheart, from whom the jail-breaker secured \$300 in cash. Stayed there until the morning of the 16th, when he woke up to find pal and all hism oney gone. Immediately took blind baggage for Milwaukee in search of the betrayer of his confidence. Found friends in Milwaukee and was directed back to Minneapolis, whither he came as soon

s possible. Smith was in Minneapolis on th night of April 21, the date of the Sather shooting. After the shot which wounded Sather was fired, a man was seen to run toward the union station. Smith was in Superior again April 22 and had to remain there several days waiting for more money, and thus was captured.
