CITY FATHERS HOLD IMPORTANT SESSION

Park Commissioners Granted but \$5000, After Lengthy and Lively Debate.

OGDEN, Feb. 8 .- The matter of appropriation for improvements and mainnance of the parks and public grounds of the city during the present year, reached their climax at tonight's session of the city council, when \$5000 was voted the park commissioners for this purpose, the appropriation being granted by a vote of 7 to 3 after a long debate, in which every member of the council took part. The park emmissioners asked

for \$18,000.

As forecasted by The Tribune, the council revoked the retail liquor license held by the Apex saloon upon the recommendation of the police committee. D. E. Bramlett and B. G. McGuire, the proposed of the piace, are now under indictinent for robbery, alleged to have been committeed in a room above the saloon. It was further decided that no fleense to sell liquor under the saine roef be granted during the present year.

Andersom & Larsen, the lowest bidders for the work of repairing elatten sprinklers for the city and three wheel scrapers, at \$100,125 and \$22 respectively, were awarded the contract for the work. The report of the city and three wheel scrapers was fallence on hand of \$45,510.60. The treasurer was instructed to furnish the council at each session a statement showing the financial condition of the city.

Chief of Police Browning submitted his annual report, which was referred to the police committee with authority to have another cony printed for exchanges with police departments of other cities.

Attorney Joseph Chez addressed the council and submitted a petition signed by 194 morchants and business men of Ogden, asking that the licenses of pedders and street vendors be increased to an amount equal to one-half the monthly rental of an ordinary storehouse. J. S. Carver, from the Retail Merchants association, followed Mr. Chez with a few remarks along the same line. The matter went to the special ordinance committee for report.

A request from the Gamble & Robinson Commission company, who contemplate the erection of a building in which a wholesale finit packing business will be conducted at Twentieth street and Wall avenue, was rejeived asking for permission to lay a spur track on Twentleth street. It was referred to the city engineer, city attorney and the street committee.

COUNTY COMMISSIONERS HOLD REGULAR SESSION

Owing to a number of complaints which have been received from merchants of the county protesting against the unrestricted habit of peddlers selling their wares throughout Weber county, a committee composed of Chaleman Madson and County Attorney Jensen was appointed to draft a peddlers' ordinance. A number of bills were passed upon and other routine business completed the business of the session.

WEISER, Ida., Feb. 8.-The Washingon fail contains more prisoners today than ever before in its history, and the eriminal calendar of the district court, which convenes here next week, will have more criminal cases on it than ever before in the history of the court for this county. Three men will be tried for crimnal assault, one of the parties being a brother of the girl who preferred the charges, one murder case, two for forgery, and several grand lorceny cases.

Arthur Sweet, who is charged with rape upon the person of his sister, a girl Jiyears of age, and who escaped from the county lail about January 1, and was searched for far and wide by the officers, voluntarily returned to the jail about 3 a. m. Friday morning and demanded to be locked up. As neither the sheriff nor his deputy was present, a trusty who was sleeping in the sheriff's office telephoned to the home of the deputy sheriff, and he went to the jail and locked the young man up. A. C. In the latter part of the month of December, Moore was found in his cabin unconscious. He was taken to the county poor farm, where he lingered for several days, never regaining consciousness. Two or three weeks after his death, there were rumors of foul play dreulated. A coroners jury was impaneled, the bedy exhumed and an examination conducted. It was ascertained that his skull had been fractured and there were a number of bruises on his body. An investigation was begun, which resulted in the arrest of Biggerstaff, who was working for the Idabo-Gregon Light and Power company at Copperfield Or. He claims he is innocent, but admits he had a fight with Moore.

ELEMENT OF DOUBT IN CAUSE OF DEATH

Word has been received, however, that the San Francisco coroner's jury falled to ascertain the cause of death, its verdict being: "Cause of death undetermined, perhaps heart failure, perhaps asphyxiation." The autopay revealed no trace of poison in the stomach and it is now believed that death was due to some other cause.

The chief of police of San Francisco has assured the relatives of Kuhn that a thorough investigation will follow. The funeral was held here Sunday, in the presence of a large number of relatives and friends. Special to The Tribune.

Sentiment of Majority of Legislators Is Against Further Division of Counties.

It is the general opinion that the vote on the question was that of the combine said to have been entered into at the beginning of the session calculated to defeat all county division bills and prevent the removal or changing of any state institution. A number of persons, some of whom were for and some against the measure, have been here for a number of days from the counties that would have been affected by the passage of the bill, doing all possible for the interests they represented.

The anti-gambling bill was given a setback, the committee referring it back for amendment. It is doubtful if the measure will receive the support of the present alleged reform majority when the test comes. So it has been with other reform measures that have come before the lawmakers this session.

One of the most important bills introduced in the legislature was presented in the senate today by Davis. It provides for making it a felony for any person, company or corporation to contract to deliver more water for irrigation than it has title to under the laws.

State Treasurer Hastings appeared before the senate for the second time during this session to explain his bill to legalize his method of handling "collection" accounts, over which there has been much heated controversy. The senate went on record as favoring all of Hastings bills along this line in the senate of the latings is bill along this line.

The following bills were passed: To establish an agricultural college fund; regulating employment of wages in United States money or its equivalent; regulating the liquor traffic, cutting out brewery-owned saloons and dives.

The measure providing for the turning of one-half of the revenue from saloons into the rural school district funds was defeated, and the senate local option bill, which was to have come up as a special order, was put over till temerrow, when a red-hot fight will take place.

The senate joint resolution providing for a constitutional amendment authorizing the legislature to prescribe the membership and number of members of the board of education was passed unant-mously.
