Surgeon General Hamilton, of the marine hospital service, in his annual report for the fiscal year ended June 30, 1884, says it is estimated that there will be a deficiency of at least one hundred and seventy-five thousand dollars in the fund for the support of the service by the end of the present fiscal year, caused by the abolition of the hospital tax by Congress. Of the new hospitals authorized by the act of August 7, 1882, those of New Orleans and Cincinnati are nearly ready for occupancy, that at Cairo is under contract, and for that at Baltimore an excellent site has been secured. Referring to the existence of cholera abroad and the precautions taken against its introduction into this country, the Surgeon General says: "Quarantine measures which are effective against yellow fever are not equally so as against choiera, and all quarantines should be conducted as inspection and disintecting stations in addition to proper isolation of the sick. But quarantine measures, however efficient, will not alone suffice to prevent an epidemic of cholera in this country if it should once
