his first mass at that institution. Five Years Earlier Than Usual. While the curriculum of the theological institutions of the Society of Jesus usually demands that a student shall pass sixteen years of preparation for ordination, Father Himmel was priested five years earlier and directly assigned to missionary work. summer home of the Jesuits, where he re-

mained for nine years.

# DEATH WAS BY SUICIDE

CORONER SO DECIDES IN CASE OF COLORED WOMAN.

The body of Mrs. Maria Brown Hungerford, colored, thirty-five years of age, was found in her apartments at 1716 10th street this morning about 8:30 o'clock. The gas fixture in the room was open, and the woman's husband, Thomas Hungerford, told the coroner that his wife had taken a black powder last night. The dose, he said, had rendered her unconscious, and he relieved her by giving her an emetic. His physician told him to return and let him know if his wife's condition became serious, but the next time he saw her she was dead. The husband is employed in one of the local libraries, and the deceased worked at the house of Mr. Neal, 1431 R street. Hungerford left his wife last night shortly before 12 o'clock to go to his place of employment, he being a night watchman. He had given her the emetic and walked the floor with her for a long while before he left the house. His wife had told him that she felt all right. During the time she was delirious she repeatedly called for her mother. She would not tell her husband what the black powder contained or where she had obtained it. Hunger-

#### ford took the glass containing the powder and hid it, in order to prevent his wife from taking another dose May Have Been Accident.

Despite the occurrence during the fore part of the night, the husband told the coroner that he thought the gas had been turned on accidentally.

"Had Mrs. Hungerford ever said anything about committing suicide?" the coroner asked Mrs. Pierson, who resides at the 10th street house.
"I have neard her say that she never would do it?" was the response of Mrs.

Mrs. Pierson is employed as a charwoman at the library where Hungerford is on duty as watchman, and this morning she was asked by him to look after his wife when she returned home. The woman went to the sleeping apartment of the Hungerford's and found the gas turned on. She summoned a physician. The latter announced that life was extinct. He called the coroner and informed him of the death of the woman. It was stated to the coroner that Mrs. Hun-gerford has suffered from indigestion for a number of years, and that at times she had said she would be better off dead than alive. The coroner gave a certificate of suicide and an undertaker prepared the body for burial. It is the intention of the husband to take the remains to Casanova, Va., where his wife was born, for burial. The funeral will probably occur next Monday.
