President Taft, Secretary Knox and Other Prominent Men to Make Addresses.

Men who worked with him in the solution of great national problems will pay tributes to William McKinley at the first annual banquet of the Ohio Society of Washington at the New Willard next Monday evening. President Taft, Secretary of State Knox, Secretary of Agriculture Wilson, former Vice President Fairbanks and Senator Dick of Ohio will tell of the particular phases of his character that came most directly under their observation.

Besides these, Justice William R. Day of the United States Supreme Court, president of the Ohio Society, will speak briefly on McKinley, under whom he was first assistant secretary, and later, Secretary of State.

Known as McKinley Dinner. The affair will be known as the McKiney dinner of the society. McKinley's birthday falls on Sunday, and the celebration will be held Monday night. By a coincidence, the first regular meeting of the society, last January, fell on Mc-
