## ROSEHILL CO. AND LA SALLE BANK TO BE PROBED

Relations between the Rosehill Cemetery Co. and the defunct La-Salle Street Bank to be probed by

the state's attorney's office.

Charles B. Munday was vice president of the bank and treasurer of the Rosehill Co. He is charged with having bought the controlling interest in the cemetery company two years ago for the purpose of manipulating the \$800,000 fund set aside for the maintenance of the property.

Downstate bankers interested in Munday's banks made poor witnesses before the state's attorney. This latter fact may be accounted for inasmuch as they were guests of Munday at a house party given at his Drexel boulevard home recently, as was also J. K. Seagrave of the state auditor's office, according to the affidavits of investigators.

MRS. WAKEFIELD GETS LIFE

New Haven, Conn., July 31—Sobbing in her cell in the county jail, Mrs. Bessie Wakefield, 19, waited to be called before Judge Reed today, when she will be sentenced to life imprisonment. The jury which heard the evidence in Mrs. Wakefield's second trial on a charge of complicity in the murder of her husband returned a verdict of second degree murder. This means that her two children, the oldest only 6, will have only the care of their poverty-stricken grandmother and may become public charges.

Mrs. Wakefield was first convicted of first degree murder with James Plow and was sentenced to be hanged for the murder of William O. Wakefield. Plow paid the death pen-

alty last March.
