Louislana Democrats Indicted.

CUSTOM-HOUSE GRAND JURY AND WIT-NESSES FROM THE CAME FIELDS.

NEW ORLEANS, February 13.—The litical prosecutions in the United States District Court for this district are becoming serious. Already indictments against nearly a hundred prominent Democrats have been found, with prom-Democrats have been found, with promises of many more. The Grand Jury, largely composed of men holding official positions in the Custom-House and others intimately connected with the Republican party, has been organized for a special purpose and is doing its work well. The evidence on which the indictments are obtained is not worthy of credence. The witnesses are ignorant negroes, who are brought to the city at the expense of the Government and paid §3 per day for such time as city at the expense of the Government and paid \$3 per day for such time as they may be away from home. When it is remembered that these men rarely receive more than \$22 per month for labor in the cane or couton-field, it can readily be seen how easy it is for the representatives of the Government to obtain men to swar to avortion. obtain men to swear to anything. have but to visit the first field have but to visit the first field you come to to obtain men who for \$3 a day will swear, if the exigencies of your case require it, that they themselves were killed by Democrats on election day, and that they have been restored to life by Divine interposition to bring the guilty to justice. And it is with instruments such as these that the present Administration is doing its work. Under the present law the test oath is administered to all jurors, and such as cannot take this oath are not qualified. cannot take this oath are not qualified to serve. Outside of the Custom-House there is scarcely a man in the State who can subscribe to this oath, and there is certainly not a man in the Custom-House who is fit to try men for crimes House who is nt to try men for crimes alleged to have been committed against the dignity of the Republican party. The zeal of the District Attorney and the United States Marshal seems to be the United States Marshal seems inspired from Washington, and it is said that their retention depends on obtaining convictions. It is estimated that about thirty of the more prominent among those arrested will be convicted. Loungers about the Custom-House will bet that General King, Congressman-elect from the Monroe district, instead of taking his seat in the next House will be sent to the Pen-itentiary. He defeated Ludeling, and his arrest and prosecution were insti-gated by his disappointed and vindictive opponent. The General is a man of education and culture and the last man in the world to have committed the crimes charged against him. His social position is the best, and to talk about his having intimidated the voters of his district is sheer rubbish.
