CIRCULAR.

To the Voters of Tippah, Pontotoc, Lafayette, DeSoto, Tunica, Coahoma and Marshall Counties.

FELLOW CITIZENS:

The Legislature at the late called session having provided that the Clerk of the District Chancery Court, be elected by the people, I, having become a Candidate for that office, have adopted this mode of presenting my name before the people of the District, from the fact that it will not be in my power to see and become personally acquainted with all my fellow citizens, from whom I am soliciting suffrage.

The first and highest of our earthly duties is the support of our family, and to this end I have been most anxiously and industriously engaged in my profession, until much affliction and ill health have greatly impaired my ability to undergo the arduous duties connected with its pursuit, and imperatively demand that I shall desist from the labours and exposure consequent upon my professional avocations. To discharge this duty then in my case, I must abandon it, if it is possible for me otherwise to procure the means for its accomplishment. Believing that both my education and pursuits in life, together with a desire closely to apply myself in the discharge of the duty that may be incumbent upon me, will fully enable me to fill with entire satisfaction to the country the station to which I aspire. I have for many years past been a resident of Holly Springs, and have become pretty generally known to the citizens of Marshall County. By such a character as I have formed among those who have known me longest and best, I am willing to stand or fall. And when the inquiry which is proper and right to be instituted in regard to all Candidates for office shall be made, I be honest—I be capable—I be faithful to the country?
