STORM OF YESTERDAY.

Telegraphic Communication Through-

Eastern New England Crippled.

Boston, April 9.-It is seldom that the second week of April brings such a wintry storm as that which prevailed throughout New England to-day. Cold, disagreeable conditions which set in last Saturday seemed to culminate today in a disturbance which attacked New England from the south and dragged into its unusually deep vortex. northeast gales accompanied by snow, rain, hall and sleet. Telegraph and telephone wires which withstood many severe snow storms during the past winter fell under the weight of wet snow and sleet, and for several hours to-night telegraphic communication throughout eastern New England was prostrated.

The storm center, unusually well defined and with almost a record-breaking low barometer, passed across Cape Cod in the vicinity of Hyannis about dark to-night. The barometer at Nantucket sank to 28.82 and in this city to 28.86, the latter being within .08 of an now and the summer of 1908. There is inch of the Boston record.




