

The Consolidated Copper Queen Mining Company has been made the co-defendant in a five thousand dolar damage suit against one of the employes of the company who caused another employe to be arrested on illeged false charges of forgery.

The district attorney's office of Fraham County has filed suit to collect bond forfeiture of \$500. It is unlerstood that this is the first suit of he kind ever brought in Graham ounty. The bond was given by Rito Vasquez, who was sent up from Clifon for attempt to kill. Julian Galan and Romulo Chaves are the sure-

A telegram has been received at the office of the governor saying that he sheriff of Mohave County had attached the postoffice building and fixures at Chloride and that the mail was being interfered with. The attachment was said to have been made on a judgment against Postmaster Charles O'Connelly. The governor referred the dispatch to the office of the United States attorney.

Bisbee's public schools employ tweny-two teachers. Several lengthy aricles have recently appeared in the Bisbee papers comparing Tucson and he mining camp much to the disadantage of Tueson. The public schools of Tucson employ over forty teachers. This comparison, the most significant feature of a city's progress and true advancement, is somewhat detrimental to the mining camp.—Tucson

Deer and wild turkey are subject to the skill of the hunter from September 15 to December 1. Duck, geese and doves are not protected, except as o the taking or destroying of eggs. 
