## WANT HENEY IN ALASKA

San Francisco, May 16—Prosecutor Heney has been approached by a delegation of Alaskans, asking that he go north and help in the prosecution of men who have been jumping claims and giving perjured testimony to uphold their cases in court. He said that his time was fully occupied for a year yet, but that he would consider the matter later.

Rome, May 16—Mount Aetna is now emitting dense smoke and ashes from the crater and the people are greatly alarmed over the possibility of an eruption. Last night a heavy thunder storm was raging around the summit of the volcano.

## PROSECUTE HARRIMAN

Washington, May 16—Following an announcement made yesterday by the interstate commerce commission in the report on the trial of Harriman, to the effect that all competition among the western roads has been eradicated by Harriman, Roosevelt directed the department of justice to start criminal prosecution against the railroad magnate for conspiracy in restraint of trade. An action will be started as soon as the matter can be put in shape by the department.

A. G. Baker is now in the Valdez hospital suffering from an attack of erysipelas. He was taken ill day before yesterday, and removed to the hospital. The office he has been occupying in the Copper Exchange, has been closed and fumigated.

## MINERS ARE ENJOINED

Fairbanks, May 16—An injunction has been granted the mining operators, preventing any of the striking miners from interfering in any way with the workings, or the non-union men who have been employed in their places. There is no prospect of a speedy settlement of the strike.

Des Moines, May 16—Five school girls of this state took an oath during the winter that they would all die together, and this morning a message was received by four of them, who are now in different parts of the state, announcing the death of the fifth. Each of the four immediately took strychnine, two are dead and the others cannot live.

## DOMES CASE NON-SUITED

Fairbanks, May 16—Upon the motion of the defendants in the celebrated Dome creek case, a nonsuit was granted against Barnette by Judge Gunnison yesterday. This is the case which Judge Wickersham refused to try, and for which Judge Gunnison came to Fairbanks. The interests involved were very great and valuable, and this settlement will throw a large number of rich claims out of litigation and enable them to be worked.

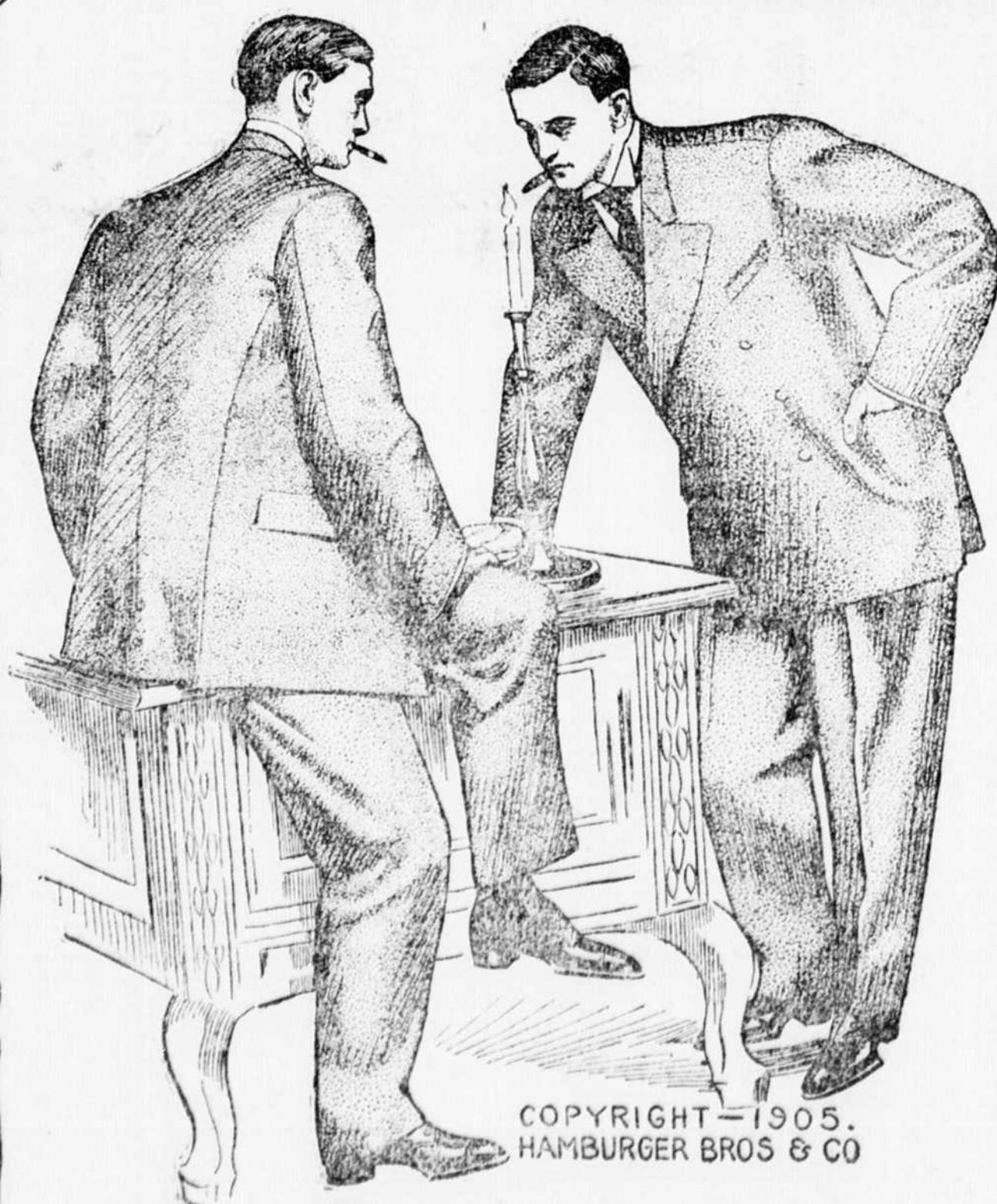
New York, May 16—An ivory crucifix valued at \$50,000 was stolen from the home of Dr. Carter last night. There is no positive clue to the thief, but it is believed to have been an art collector, who wished to own the valuable relic.

Washington, May 16—It has been determined that Vice-president Fairbanks will visit Alaska during the summer, but the details of route and time of coming are not arranged.

Boise, May 16—Twelve jurors have qualified for the Haywood trial, but today the state and defense will use their preemptory challenges, after which the prosecution will re-examine the jurors regarding their prejudice concerning the Orchard confession. Borah says that the state relies entirely upon this confession to convict the accused.

San Francisco, May 16—Abe Ruef, in an interview here this morning said that he wanted to break with Schmitz before the latter's re-election, being dissatisfied with Schmitz's appointments of labor union bums to fill the city offices.

San Francisco, May 16—Abe Ruef pleaded guilty to the charges against him of practicing extortion on the French restaurants of the city, and will be sentenced a week from Monday. After pleading Ruef collapsed entirely and had to be carried from the court room. Mayor Schmitz, who was indicted jointly with Ruef on the same charge, will have his trial Monday. He declares he will stand pat, but Heney says he has a better case against the mayor than against Ruef.
