which was heartily greeted.







Austrian Politics.

The resignation of Austria's ministry shows that the political troubles in that country which caused alarm throughout the Empire in the past year or two are not ended yet. The serious feature of these troubles is that the Emperor Francis Joseph, who has been on the throue for half a century, and who is very popular in all parts of his polyglot domain, is in his seventieth year, and is said to be in feeble health. The parliamentary deadlocks and falls of ministries are not likely to result very harmfully while he remains, but his successor will not have the same prestige and influence. This consideration gives a world interest to Austrian politics at the present time.
