

THE CO-PARTNERSHIP HERETO-

(From the Chillicothe Advertiser.) The Legal Status of the Rebel State Authorities During the Rebel-

A gentleman of this city has been furnshed by R. W. Tayler, Comptroller of the Treasury, with a copy of his report, made Aug. 15, 1865, to the Secretary of the Treasury, upon the "Texan Indemnity Bonds." R. W. Tayler was a Republican Senator from Mahoning county, from 1856 to 1860; then Auditor of State, which position he resigned for his present one on the death of Eisha Whittlesy. During the last two years of his Senatorial career, Mr. Tayler was the acknowledged leader of his party in the Legislature; and white known to be, in polynomia. ties a man of the Chase school, was recognized by all who knew him as one of the ablest men in Ohio. These Texan Bonds had been issued by the U. S. to that State prior to the Rebellion. The State had agreed to negotiate a part of them for railroad purposes, and after the Re-bellion and attempted secession of Texas, this agreement was completed by the rebel State officials, who indorsed the bonds to the present holders. Among others the question then arose, whether these holders had such title as rendered the U. S liable to pay the bonds and interest to them. We re permitted to copy the following from

Mr. Tayler's report. The italics are ours. From page 16 to 19 Mr. Tayler says: "Besides, it seems to me the disloyalty of the State officers did not deprive them or their local powers-of their power to dis-charge their duties as officers of the State affairs. It will not do to hold that the acts of these officers in conformity to law, up to the date of the ordinance of secession, are legal and binding, and that all such acts done after that date are null and void; that by such act of Rebellion the State officers abdicated the Government. If this were to prevail as law, and the official acts of offieers of the State are to be held as filegal and void, it is equivalent to holding that Texas was in a state of anarchy, and the official acts of every officer deriving his power from the state also illegal and vold. A moment's consideration will show how untenable and inadmissible such views nust be. If the fact that the Governor and Legislature, in whom were vested the highest powers of the State, and through whom all local and interior powers were derived, were in Rebellion, made null and void the acts of such Governor and Legislature, then must the acts of all other officers deriving their powers through such disloyal Governor and Legislature be null and void also, whether such other officers were or were not themselves disloyal. So that the laws of the State by which her people were governed; the acts of the Executive in preserv-ing and promoting order and happiness, the judgments of the Courts in administering law, and the execution of those judgments by the recognized officers; all conveyances of real estate, when the deed was acknowledged before a State officer, and all marriages sol-emnized under the laws of the State by a disloyal or even a loyal justice or minister, would be null and void. Children born in what was deemed lawful wedlock would be illegitimate, and illegality would prevail over everything and over every interest, social and material, throughout the whole State. But such is not the law. The regular discharge of local powers, not directly connected with the Rebellion, must in any event, he recognized as legal and proper. It would be so though the local Government were an usurped one, and the officers usurpers-which they were not; the Government and the officers were such as the people of Texas chose for themselves; onduct and management of their State affairs. Neither the State, nor the people

to whom they gave power over their com-mon property, and in whom they vested the of the State, can now object that the acts of their officers are illegal; and, for most purposes, it would be the same had the Gov-ernment been an usurped one that was finally overcome and expelled by the rightful one. The latter could not treat the acts of the former as void. The history of the civilized world is full of instances where Govern-ments held to have been usurped were yet, when put down, held to have been Governments, in fact, and their acts, except when they troubled the prerogatives of the crown or the form of Government, valid and binding on the Government. When the Government of one nation seizes upon that of another, it, for the time being, becomes possessed of all the power and rights of the expelled Government, lawfully takes its revenues and property, and disposes of them, and executes the laws; and its acts, when it has again surrendered its possession to the rightful Government, are binding upon the latter. This is a part of the law of nations, and applicable not merely to the case of invasion and expulsion, but to usurpation and restoration also. Governments must exist and be recognized-laws must be executed; and this can be done by those only who have possession of the powers of Government, for the time being. Lord Reep-er Whitelock, though friendly to Charles, accepted his position from Cromwell after much hesitation, because, the business to be undertaken by him was the execution of law and justice, without which men could not live one by another; a thing of absolute necessity to be done. So with Sir Matthew Hale, who was a royalist, upon his appointment to the Bench by Cromwell, he at first refused, because, he was not satisfied with the lawfulness of the Protector's authority. Cromwell answered that he had possession of the Government, and would keep it, but still that it was his de sire to rule according to the laws of the land, for which purpose he had nominated him, and that if he was not permitted to reign by red gowns, he would by red coats. Hale yielded upon the advice of royalists, but he entertained strong objections to presiding at criminal trials; with State prosecutions he would never meddle.

"A revolutionary Government succeeds to both the rights and obligations of its prede-cessor. In the meantime, before its complete and recognized establishment, it is the Government of the State. Should it be finally expelled its acts are not to be held void. Whatever may have been done by it, that was within the powers of the legiti-mate Government to do, is binding upon that Government when restored, at least so far as relates to the administration of the laws and the use of the public revenues and property.

"As to public debts, whether due to or from the revolutionary States, a mere change in the form of Government or in the person of the ruler does not affect their obligation. The new Government succeeds to the fiscal rights, and is bound to fulfill the fiscal obligations of the former Government. It becomes entitled to the public domain and other property of the State, and is bound to pay its debts previously contracted (Wheaton's Int. Law, pp. 52-3.)

"And wrongs done by a usurped Govern-ment towards the citizens of another coun-try must be answered for by the rightful Government when restored. As to wrongs done Government or citizens of another State, it seems that, on strict principles, the nation continues responsible to States for damages incurred for such wrongs or in-juries, notwithstanding the intermediate change in the form of its Government or

on the the person of its rulers (Ibid. p.57). On this point the U. S. are committed by their argent, long continued, and successtul prosecution of claims of our citizens against France and Naples. Of necessity this must be the rule. A State does not come to be a State when its powers are usurped, nor when a revolutionary Government gains possession of them. It is still a State, whoever may manage its affairs. The State is the primary and chief thing. The Govern-ment is but an incident, though a necessary one, to it, and is the representative of the State through which its powers are exercised. The two are inseparable. A State without a Government is an impossibility, and so is a Government without a State. ernment is the lawful Government, though it may not be the rightful one; and whatever it may do within the scope of its authority, is binding upon itself, and also upon the rightful Government when restored. Texas was an existing State, having a regular form of Government, adopted by the pea-ple, and conducted by agents of their own selection. There was no revolution or usurpation of the State Government, but there was rebellion against the United States. Texas was fully competent to dispose of her own property in her own way, and for her own purposes; whatever may have been the attitude of her people and her authorities towards the United States."

### [From the Obio Farmer, Dec. 2.] The Wool Trade.

From our eastern exchanges we quote without comment, the following to show the reported spirit of the wool trade: In New York, the Economist says: "Wool has been very quiet another week, yet, we think, with less disposition on the part of holders to press sales, and with no spirit of speculation, comparatively little wool bas changed hands; but the little that has been has commanded better prices than might have been expected under existing circumstances. The large amount of rain that has fahen during the week has settled the question with reference to the running of the mills. There is no doubt that all the factories are now in full operation, and are consuming now daily an enormous amount of wool, which is rapidly reducing the stock in the hands of the manufacturers, which every one believes has never been extremely large this year; and the holders of wool generally are of the opinion that all the wool will be required before another clip, though there may at no time be a very great rush into the market by man-ufacturers, they knowing that if they should commence and buy freely, prices would as rapidly advance; and as it is the business of every one to buy as cheaply as possible, it is their policy to enter the market as cautiously as possible, and buy as sparingly as their necessities will admit. We do not look for anything very lively in the market before New Years. The highest price which the very finest and best condiioned wool brings at the present time in this market is 850 currency. In our en-deavors to obtain something tangible about how far the price of wool has given way, we find them almost fruitless; a great many say they have not sold for any less, nor are disposed to abate one fraction of a cent; others say that the price has given way to some extent. We have endeavored to so revise our price list as to represent the val-ue at which wool is held, and if, by reason of pressure from circumstances, a departure is made from those quotations, we cannot be held responsible, for we can only give the asking price. For entire lots of West-ers, 57½ to 66c; Michigan, 62 to 65 to 68 to 70c; Ohio, Pennsylvania and Virginia, 68 to 70 to 75c; New York, 58 to 60 to 68 to 70c; Western grades, coarse, 52c; medlum, 56c; fine, 60 to 65c; Michigan and New York, full blood, 68 to 72c; 34 do, 65 to 6734c; 34 do, 624c to 65c; 34 do, 60 to 6234c; common do, 55 to 60c; Ohio, Pennsylvania and Virginia full blood Saxony, 80 to 85c; full blood merino, 73 to 75c; ¾ do, 72¼ to 75c; ¼ do, 70 to 72¼c; ¼ do, 67 to 70c; common

lo. 60 to 66c. In Boston the Com. Bulletin reports: "The wool market exhibits no new feature. Trade is quiet as usual at this season, and buyers continue to hold off or to operate only to the extent of present wants, which are not very pressing owing to the torpid state of the goods market. There are no large lots moving and propably will not be till the close of the year, when manufac-turers, having squared their accounts, usually begin to stock up. There is a moderate inquiry for fine wool to supply those mills which are running on light spring goods. But even this grade is wanted at rather low prices, and the views of buyers and sellers are apart. Though receipts con-tinue liberal, (amounting to some 5000 bales of all grades domestic, per week) and rather in excess of the current con-sumption, the stocks of really choice staple are by no means large. The whole supply in the country is confessedly inadequate to the requirements of home manufacture. It will all, and more than all, be wanted for consumption during the next few months, as imports to any extent are out of the question at present prices: Prices for the lower grades of staple are rela-Coarse wools are not wanted at this season, and undesirable lots of Western could not be forced off except at a material concession. But choice parcels of pulled wook and of Ohio and Pennsylvania fleece, suited to the manufacture of Spring sackings and light fancy cassimeres, are not pressed upon the market and cannot be quoted lower. Sales of domestic for the week foot up some 375,000 lbs. at a range of 55 to 80c for fleece, and 60 to 62\frac{1}{2}c for the various grades of pulled. The transactions have been wholly in small lots, hardly worth while to note in detail, and include numerous par-cels of common Ohio at 70 to 72½0, fine do at 75 to 78°, and choice selections do at 80°. at 75 to 78c, and choice selections do at 80c. There are some fancy and double extralots, however, in the market, which are held

above the last mentioned figure." In Philadelphia the finest grades have steadily maintained their prices, but the coarser have suffered a slight decline, and in very limited demand. Ohio fine is quoted at 70 to 75c, and full blood at 79c.
