GRANT's COUSIN SILAS. Washingrow, D. O., Oct. 21.—The manifest impatience which exists in influential Adminis-tration eincles with regard to the condition of affairs in Cuba has iii iii wise been diminished by the tendencies of events in tifft island during the summer, and especially by the recent arrest and imprisonment of Henderson. The State Department here has become a vast receptacle for complaints, official and unofficial. As to the high-handed outrages committed by the Spanish-Cuban authorities on Americans and American property; the American Consular representatives in Cuba firse their lack of power o protect our citizens from inwisseness, their unctions being simply conflited to commercial natters. However, they represent that where they have made personal representations to the Spanish authorities on behalf of American citizens travelling or having business in the island, their representations have, in almost every in been disregarded, or treated with positive contempt. It is claimed Cuban sympathizers that, notwithstanding the short session, Congress, this winter, will be compelled to take some action with regard to Cuba, which it neglected to do last session. The sympathies of the House Foreign Affairs Committee, with its Chairman, General Banks, are favorable to such a policy in this direction as will either guarantes immunity to American citizens in Cubs in the first instance; or provide for a speedy reckening with the Spatish muthorities in the second. It is well known that the President has always been favorable to adopting stringent measures for the protection of American interests in this quarter; but that he has been controlled by a conservative influence, which seems yet to be very potent. It is even claimed that this same influence procured the alteration of the paragraph in the President's last ainual message; which the latter wrote himself, and which, as originally written, would have given Congress some encouragement in determining a firm policy with regard to this troublesome plan. last session. On the other hand, the Spanish representatives here consider their Government the aggrieved party in all these troubles. They point to the difficulties with England just settled by the Geneva Conference as precisely the case which Spain can make against our Government on the Cuban count, and as an offset to the tremendous claims which are now being filed before the Spanish-American Commission on account of the damages inflicted to the property of United States citizens.

JAMES RIVER AND KANAWHA.

There is a disposition, on the part of a number of Southern Congressmen, to make an effort, this winter, to obtain Government aid in behalf of the James River and Kanawha. That this is an old and favorite route and scheme, and was in a fair way to attract public attention when the rebellion broke out, and all enterprises of this character were abandoned. It is thought that the commercial situation this winter will be extremely advantageous to the success of this scheme. The arguments in its favor are a nearer and more direct route for the shipment of Western staples to the sea-board, and an outlet which through its completion will regulate the high rates of transportation now prevailing on the Eastern lines of transit. It is estimated that \$10,000,000 would complete this canel, which, when finished would afford an uninterrupted line of water communication, between the Western navigable rivers and the sea-board.
