MR. CLABAUGH'S DEATH.
Mr. E. A. Chabaugh, one of the best-known turimen in America, died at his residence, Hagerstown, Md., tast Tuesday. By profession Mr. Clabaugh was a banker, being at the time of his death President of the People's Bank of Baltimore. Although more or less interested in turf sports from his childhood, it is only within the past, five years that the deceased gentleman has been prominently before the public as a breeder and owner of race-horses. He had a fine breeding farm at Clover-brook, Md., from which have graduated such well-known animals as Clover-brook, the control of the co brook, MA., from which have grantated such well-known animals as Vistor, Piccolo, Oden, Cloverbrook, and Catoetin, making arrangements for great improvements h his racing stud. It was at the spring meeting at Baltimore in 1875 that the subsequently well-known ruby and blue jacket of Mr. Clabaugh made its its first appearance, the rider on this occasion being Fisher. Mr. Cinbaugh's first runner was Violet, who failed to get a place in runner was Violet, who failed to get a place in the Chesapeake Stakes, won by Firework. During this meeting Viator and Piccolo made their first appearance in Mr. Clabaugh's colors. Viator was one of the best 2-year-olds of his year, but having to meet such good ones as Aristides. THE BOULEVARDS.

Slow Progress Owing to the Unfavorable Weather.

The progress of the work on Michigan avenue boulevard the past week has been as great as could have been expected, considering the unfavorable weather. The laying of the flagging has been substantially completed to Thirty-lith street, the curbing is finished, and the catchbasins are all in. The sub-material for the

basins are all in. The sub-material for the roadway as far south as Twenty-ninth street is being put in, and the delivery of gravel, which was stopped by the interference in the many stopped by the interference in the boulevard end, is completed. The avenue has also been cleaned from Twenty-ninth to Tairty-lifth street during the week, the intersection of Twenty-second street has been paved with graint blocks, the planting of shade-trees has extended as far south as Eighteenth street, and the work is being pushed generally with all possible rapidity, and will be continued until the weather interferes. The Commissioners are confident that the entire boulevard with be completed and ready for use by June 1, and possibly somer if the weather is as favorable as it promises to be.

WEST WASHINGTON STREET.

But little progress has been made on the Washington street boulevard during the past two weeks. This has been parity owing to the bad weather and partly to the non-arrival of granit from Waterloo, Wis. A break in the St. Paul Rond has been the cause of the delay in the granit, but it is expected to arrive in sufficient quantities this week to enable that part of the work to go on. The lamp-posts that were already on the street have been reset, and connections made for the additional number that will be required. About 100 holes have been dug for the planting of trees, and manure-heaps for the protection of the trees placed along the street as far as Union Park. Work will be commenced tomorrow in tree-planting, and a large force of men will be employed by Mr. Peterson, the tree-contractor, for the purbose of doing the work before the ground freezes up.

That part of the boulevard completed—from Halsted street to Carpenter—is apparently in excellent condition. There is no mud whatever to be seen, while the streets crossing the boulevard are in an excerable condition from the recent rains. It is aimost impossible for vehicles of any description to go on Carpenter or Morgan, so deep is the bund. It would seem as if the sign "No Bottom" should be placed on some of the mud-holes on those streets. Yesterday quite a number of carriages that drove west on the boulevard as far as Carpenter were obliged to return, there being no safe outlet on any of the cross streets. Should these streets not be paved ere long, vehicles will carry mud on the boulevard and destroy its cleanly appearance. WEST WASHINGTON STREET.

lugham. When tried, the jury disarreed. Judge
Tuley said the only eye-witness was a Chinaman,
and if his evidence was taken as true, the case
was clearly one of self-defense. The evidence
on the part of the people against the prisoner consisted really of admissions, which
were sworn to by only one witness. From the
fact that his knowledge of the English language
was very imperfect, and that these admissions
were to be taken with a great deal of caution,
particularly under the circumstances of the
case, the Court was inclined to the opinion that
any further proceedings on the part of the people would result in an acquittal, the evidence
leaving on his mind a very considerable doubt of
guilt. Hence he would allow the nolle to be entered, and order Wing Lee discharged.

Before he left the court-room Detective Moynaham, of the State's-Attorney's office, took him into custody. On application Judge Tuley issued a writ of habeas corpus. THEY DON'T LIKE THE BRIDEWELL.

The only thing of interest that happened in Judge Tuley's court during the sentencing of the prisoners was the application of two young men to be sent to the penintentiary instead of to the Bridewell. Judge Tuley almost always, where a hore is converted for the first ima wards bing to sent to the penticutary listend of to the Bridewell. Judge Tuley almost always, where a boy is convicted for the first time, sends him to the jail or Bridewell to avoid attaching to him the stigma of having been in Joliet. His kindness, however, was not appreciated in two instances yesterday. John Kennedy, who had been awarded eighteen months in the Bridewell, withdrew his plea of guilty to grand larceny and entered a plea of guilty to robbery for the sole purpose of behing sent to the penitentiary; and August Wonderly, who was permitted to change bis plea from grand to petit larceny, kieled because no gvot a year in the Bridewell. Kennedy's request was granted, but Wonderly's denied. This incident shows a creat lack of moral principle in both young men, and it is very evident that locking them up will not bring about reformation. Kennedy's reason for wishing to go to the penitentiary was that prisoners in the Bridewell had to sleep two in a bed. Wonderly didn't indicate any ground for his preference. Both undoubtedly not their ideas of the Bridewell from professional criminals in the jail, who do not like the institution on necount of the thorough discipline maintained by Mr. Felton.

All agreed that insurance in sound companies is a most admirable provision, but the trouble was how to determine the question of soundness. "Your trouble was mine awhite ago," spoke up one of the party, "but my mind is entirely easy now. I have recently had a large sum placed on my life in different companies, and not only do I teel certain that every dollar will be forthcoming at the proper time, but, what is equally, important, I am in possession of facts and flgures that show the status of my policies—their value commercially at any given time."

"How did you secure this information?" spoke several in chorus.

"I went into this as I do other things, on business principles. When you negotiate for a piece of land you go to an expert to have the abstract examined. To do less is to be a simpleton. Now in this case I went to an insurance expert, who devotes his entire time to insurance matters. One company is no more to him than another. He looks after your interests, not theirs. He is the attorney of the public, and his entire success depends on his ability to serve the public. A single case of bad advice would ruin him."

"Who is this expert and where can he be

"Who is this expert and where can he be found?" was the next inquiry.

"It is Mr. Mervin Tabor, and his office is in the new Grannis Block on Dearborn street, He was literally born to the life-insurance business. For many years he was prominently connected with the New York Mutual."

"How is he remunerated for his serv-· How is he remunerated for his serv

"How is he remunerated for his services?"

"It you place the insurance through his agency there are no charges whatever. The commission from the company satisfies him. But such commission does not in the least affect his judgment, for all companies pay him alike. It, however, it is only information you want, say about the soundness of this or that company, the status of your policies, their present value, or anything of that sort, he charges a nominal fee."

"It is a great comfort," continued the gentleman, "to feel free from the everlasting insurance agent. All are necessarily untrustworthy because the paid attorneys of particular companies. They present only the bright side—mone of the dark. All their information, so called, is not worth a rush. They taik you into a thing against your will, and literally you buy a pig in a poke. Heretofore fully 90 per cent of all insurance has been placed in ignorance. I am fully persuaded that Mr. Tabor's plan and niethods will completely revolutionize this business by placing the public not only in a position to defend themselves, but on vantage ground."

"I have known people to be swindled even when insured in sound companies, when constrained to surrender their polices," spoke up a member of the party.

"Exactly. I also know of cases, and right here Mr. Tabor is of most service. None out an expert can tell you what a policy is worth. Unless you can face them with the exact figures the company will offer you anything they choose and you cannot help yourself. The policy itself gives no indication what it is worth at any given time. In each case value is determined by the laws of the State, by the charter, by the plan on which business is conducted, and other things too numerous to mention. the State, by the charter, by the plan on which business is conducted, and other things too numerous to mention. Hence you can easily see that it takes an expert to give you the exact figures. Being familiar with the working of the various plans in vogue, and understanding your circumstances, he can inform you most intelligently what class of insurance is most to your advantage, whether life, limited life payment, short or long endowment, or Tontine, taking into account age, motives, financial circumstances, etc. When insurance is placed he delivers to the insured, with the policy, tree of charge, an abstract of the legal reserves on said policy for each yoar during the first twenty years. This abstract indicates the net cash value of the policy at any date during the twenty years. No insurance office furnishes such an abstract. He also estimates how large a paid-up policy should be issued in exchange for a running policy, or gives its value as collateral, and when any differences arise between company and policy-holder his advice is invaluable—worth that of a dozen lawyers; in fact, the lawyers would in all probability go to hun to get posted."
