Amendment to the Charter of the Mississippi Hardware Company, of Greenville, Mississippi.

Add to Section V the following words:
The Stockholders of said Corporation, at any regular or called meeting, by a vote of a majority of all the stock issued, may increase the capital stock to an amount not exceeding fifty thousand dollars.

Sec. V. The capital stock of said corporation is Twenty-Five Thousand Dollars, divided into shares of One Hundred Dollars each, and every share of stock shall entitle the holder thereof to one vote at all stockholders' meetings; but said Corporation may be organized, and its business proceeded with, as soon as Five Thousand Dollars of the capital stock shall have been subscribed and paid into its treasury. The Stockholders of said Corporation, at any regular or called meeting, by vote of a majority of all of the stock issued, may increase the capital to an amount not exceeding Fifty Thousand Dollars.

Add to said Charter a new Section to be numbered VIII, which section shall read as follows:
Sec. VIII. Said Corporation shall have a first lien upon the shares of capital stock issued by it to secure any indebtedness owing to it by the holder of such shares; which lien shall be shown upon the face of the stock certificates.
