HE PASSED AWAY SUDDENLY AT AMHERST YESTERDAY.

SWEET SINGER OF THE CONFERENCE.

He Had Held the Positions of Pastor Methodist Churches Here-The Funeral Arrangements.

Rev. Dr. Adam Clarke Bledsoe, one of the most prominent figures in the worker of untiring zeal and ability, died suddenly at his country home, near Amherst Courthouse, about 1 o'clock yesterday afternoon. The end is supposed though only meagre advices were received here last evening.

The news of the death of this gifted minister carried with it the most proif you wish them mailed to any address. | found sorrow to the hearts of his friends and admirers here who heard it. Among the clergy the deepest grief was expressed. Dr. Bledsoe was for several years the pastor of Broad-Street and Trinity churches here, and was held in the highest degree of esteem and personal affection. He possessed a charm which drew men unto him, and gained for him the closest confidence of those with whom he came in contact. He was a most forcible preacher. Imbued with the gift of elequence, and blessed with a splendid power of delivery, he never failed to impress his congregations.

WHEN HE WAS TAKEN ILL. Dr. Biedsoe was taken ill on the 16th day of August, while preaching at Am-herst, but had so far recuperated that he was thinking of returning to conduct services at his church on Sunday. His physician advised him not to do so, and a was received at Charlottesville yester by saying his brother, Dr. J. Wiley Biedsoe, was to fill his pulpit for him. The funeral will take place at Amherst on Sunday morning at 11 o'clock, and will be preached by Rev. Dr. J. J. Laf-ferty, of this city, a warm personal friend of the deceased.

Dr. Bledsoe was 57 years old, and a native of Buckingham county. The degree of Doctor of Divinity was conferred upon him by Emory and Henry Collego, from which he was graduated in 1899. He was which he was graduated in 1899. He was licensed to preach the same year, and the following year he entered the regular ministry of the Methodist Church. He began his life work on the Albemarle Circuit, and ended it at the chief charge in that district. He has filled the most important churches of the Virginia Conference, and during the late war was a chaplain to the Confederate army, assigned to the Fifteenth Virginia Cavalry. He was a man of splendid presence, of fluent speech, and was known as the "sweet singer" of the Virginia Conference.
