NEW YORK, April 26 .- (Special.)-The Blues have invaded and captured New York. From Quantico to Jersey City yesterday could be heard the strains of "Maryland, My Maryland," "The Bonnie Blue Flag," and other southern

The Blues are splendidly quartered at the Hotel Vendome, and the Fifth Maryland Regiment has tendered them a reception from 3 to 6 to-day at their quarters, at the Lenox Lyceum. All are walting for to-morrow's parade, and the prophecies are that the crack battalion of Virginia will take the palm.

Major Cutchins, in command of the Virginia troops, will represent Governor O'Ferrall, and is determined to show his men what it is to be in gay New York.

POURING INTO MANHATTAN, A Million or More Visitors in the Metropolis To-Day.

NEW YORK, April 25.-All day long soldiers of the regular army and the National Guard have marched through the handsomely-decorated streets of New York, from the railroad stations and ferry landings to their quarters. Every train has brought notable people to the among the arrivals being President McKinley, Vice-President Hobart, the Cabinet officers, members of the diplomatic corps. Senators, Representatives, and Governors of States. Late this evening, the last of the foreign warships, the Italian cruiser Dogalia, steamed into port. To-night a wind- and rain-storm cooled and cleared the air. To-morrow will be fair and pleasant. Everything is ready for the dedication of the massive tomb in Riverside Park, in which rests the remains of America's great soldier,

Weeks ago it was estimated that 1,000,-000 persons would come to New York to witness the parade and the ceremonies of dedication of the tomb, and that num-ber may be exceeded. In making up the parade, the grand marshal, General Grenville M. Dodge, has excluded many Grenville M. Dodge, has excluded many civic bodies which asked for places, and his given room to the regular army, the militia of the several States, and the Grand Army and kindred organizations. There will be 55.00 men in line. The white squadron lies in the North river apposite the tomb, and the foreign war-ressels are anchored below.

THE PRESIDENTIAL TRIP.

it Is Uneventful-McKinley Serenaded by Stonewall Band.

NEW YORK, April 26.-President Mc Kinley, with Mrs. McKinley, and his Cabinet; Mrs. U. S. Grant, and her family, and a company of official perionages, including the ambassadors, ninisters, and attaches of the diplomatic corps, and afficers of the army and navy, were safely transported from Washington to New York to-day in a special train of the Pennsylvania railread, to participate in the ceremonies at the tomb of General Crant.

The trip was a rapid one, and entirely aneventful. The train left Washington, where a small crowd was gathered at the after 3 o'clock, stopping only at Wil-mington for a moment, and at Gray's Ferry, a suburb of Philadelphia, where a change of engines was made. From lersey City the party was conveyed across the river on the ferry-boat Pitts-burg, to the foot of Twenty-third sireet, there to be ushered into carriages, and excepted in procession by a detachment of cavalry, sailors, and police, to the

Avenue Hotel. Seven cars made up the train. The private car of President Frank Thomp-son, of the Pennsylvania road, at the end of the train, was given to the presi-dential party. It was handsomely embellished with roses, and in it were President McKinley, Mrs. McKinley, Mrs. Saxton (Mrs. McKinley's aunt), Mrs. Saxton (Mrs. McKinley's aunt), Secretary John Addison Porter and wife, Dr. Bates, the President's private physi-House steward.

General Horace Porter gave an arm to the President, and the much-mooted quessolved by Mr. Chauncey Depew, who took the arm of Sir Julian Pauncefote and walked after President McKinley. Amsador Patenotre followed, escorted by Whitelaw Reid, formerly Ambassador of the United States to France. Abner McKinley, the President's brother, took Mrs. McKinley, and Colonel Frederick D. Grant escorted his mother, who was dressed in deep mourning. The other celebrities came after these in a disorganized group, with a cordon of valets bringing up the rear, laden with bags and boxes, containing all the gold-lace, swords, and medals which the diplomats are to lisplay on the morrow.

Between lines of police and blue-coated sailors, the company marched to the ferry-boat, where carriages were aligned on the lower deck to take them from the opposite dock to their hotels. On board the boat the President received all th bers of the Reception Committee and then stood on the lower deck, ab sorbed in the sights of the river, until the New York shore was reached.

IN NEW YORK. On the New York side, a platoon of about fifty policemen was drawn up in front of the ferry-house. Squadron A, in command of Major Roe, was awaiting as a military escort, and led the pro-cession up Twenty-third street as far as Eleventh avenue, where they turned up to Twenty-fourth street and to the Windsor Hotel. The diplomatic corps, members of the Cabinet, and justices of the Supreme Court went to the Fifth-Hotel, where the majority of

VICE-PRESIDENTIAL PARTY. General Longstreet Along-His Tribute to Grant.

(Copyright, 1897, by the Associated Press. NEW YORK, April 16.-The special train bearing the vice-presidential party to the Grant ceremonies arrived at Jersey City to-day, at 3:24 P. M. The entire trip had been uneventful.

Vice-President and Mrs. Hobart walked at the head of the procession through a small crowd on the Ratform, to the carriages which were waiting for them. were driven on board the Jerse Central ferry-boat, Fanwood, and landed at Twenty-third street, this city, whence they were driven to their respective stop-

During the run from Philadelphia to Jersey City over the Jersey Central tracks the Vice-President and Speaker Reed held their respective dinner parties.

Of the famous men who travelled on this train, perhaps none was more spoken of than General Longstreet. His venerable face and tall figure, notwithstanding he is somewhat bent with age, brought back to mind the days when, in the prima of life, he led the southern forces in many a fierce assault. Since those times he has been United States Minister to Turkey, and now holds first rank in the short list of the Confederate generals

still alive.
General Longstreet requested the Associated Press to publish a statement written by himself. He said to the correspondent that it was fitting on such an occasion that he should speak, for he was with Grant at West Point, served in the same regiment with him before the and even introduced him to woman who became his wife. The statement, as General Longstreet wrote it, is as follows:

GRANT AND RECONSTRUCTION. "It was my good fortune to know, as few others could, that Grant's heart went out in sympathy for the brave men and women of the South during the distressing times of Reconstruction, and to my o'd comrades who followed the Stars and the South and the gloom and Bars of the South, and the gloom and glory of Appomattox, I want to say that I glory of Appointer, I want to say that General Grant's heart went out to us in all of our wees. He appreciated the principle that all governments derive their powers from the confidence and respect of the people, and his great mind and patriotic heart were bent toward the re-establishment of cordial feelings between establishment of cordial feelings between all the sections of land. If every old Confederate soldier, or widow of a Confederate, to whom he gave a helping hand, could leave a tear about his tomb it would be baptized in love's best of-

His Bank Almost Penniless-Receivers for U. S. Bond Company.

MEMPHIS, TENN., April 26.-A special to the Commercial-Appeal from Atlanta, Ga., says: Harry A. Cassin, the cashier of the Georgia Savings, Loan and Banking Company, who yesterday confessed o being a defaulter to the extent of \$45,-000, and whose friends had agreed to pay up his shortage to keep him out of jail. is to-night behind the bars of Fulton prison. At a meeting of the Board of Directors of the institution which was robbed, held this evening, a brief examination of the books was made, and this resulted in the astounding discovery that barely a cent's worth of assets. Instead of the shortage being \$45,000, it will be several times that sum, and instead of young Cassin being the bearer of the entire guilt, it is now believed that at share a cell with him within the next few hours.

A remarkable chain of evidence has been the immediate result of Cassin's en ferced confession. When President G. V. Gress, of the bank, and the Board of Directors agreed with Judge Hillyer, Cas. "I am really grateful to the Greek com-Directors agreed with Judge Hillyer, Cassin's father-in-law, to make good the shortage, the matter was believed to have been settled. As the amount of the defalcation steadily increased, however, Morgan Grees, who is the son and sole heir of the bank's president, went into court with an application for a receiver for the concern. Judge Lumpkin set next for the concern. Judge Lumpkin set next Saturday as the date for the hearing Judge Hillier withdrew, and a warran and he was taken at once into custody.

Almost immediately application was made for receivers for the United States Bond Company, of which Gress is president and Cassin cashier, and the court immediately appointed them. The company has over 400 agents at work in different cities. Several hundred dollars worth of its bonds have been held as giltedged securities by people in Memphis. New York, Boston, Philadelphia, and

Following the arrest of Cassin, th Board of Directors and stockholders went into secret session, and, it is said, arranged for the swearing out of further

Manufacturing Company. The stockholders will probably be in session all night, for the books of both companies are in very bad condition.

The Greek troops have been withdrawn from that town, and are taking the wounded from the hospitals. Among the arrivals from Volc is ex-Minister Rall, leader of the opposition group in the Boule. He has been at the scene of war, and was at Larissa last Friday evening. He has published his views in the Athens newspa pers, and has already succeeded in con centrating upon himself the attention of public. Some believe he is preparing to play the role of a Greek Gambetta.

DENUNCIATION OF STAFF. "In an interview with me to-day, M Rall unsparingly denounced Constantine's staff, which he holds responsible for all that has happened. He denies that there was any real battle at Mati, says the Greek troops were never defeated at that point, and attributes the sudden decision to abandon Tyrnavo and Larissa to the cowardice and incompetency of the Gene-

"Whatever may be the value of M Rail's strictures, they seem for the mo-ment to voice the opinion of the multi-tude. The Greek populace in many respects resembles the French, and the old cry, 'Nous sommes trahis,' is being raised. It is now the fashion to denounce per-sons in high places, and newspapers which only the other day were culogizing King George and M. Delyannis for having placed themselves at the head of a national crusade, are now denouncing the

tional crusade, are now denouncing the constituted authorities.
"Some are openly attacking the Crown Prince. Others go so far as to announce that he has been recalled, the wish, apparently, being father to the thought. Journals which formerly made war are now trying to make revolution. What may be the result of the present storm of obloquy it is difficult to foresee."

TROUBLE AT ATHENS. LONDON, April 26.—The most serious feature in the Greek-Turkish emergency is the revolutionary feature displayed at Athens. Ex-Minister Rali, leader of the principal Opposition in the ex-governmental assembly, threatens that unless the military staff was changed, he would issue a proclamation to the people. His statements acted like oil upon fire, and the popular excitement, flared up. Crowds assembled in the streets to discuss them, and wanted to march to the Palace to LONDON, April 26.-The most serious and wanted to march to the Palace to read them to King George. WAR THOUGHT ENDED.

LONDON, April 28.-The correspondent of the Times at Volo, in a dispatch dated Saturday, says the general impression there is that the campaign is ended, and that the centre of interest has been transferred from the seat of war to the diplomatic chancelleries of Europe. DEFENCE OF PHARSALOS.

ATHENS, April 28.-The disposition of Greek soldiers for the defence of I salos has been carefully studied by general staff and the Minister of War, and orders have been given for the occupation of the heights at Velegetino and Pilasletepi by independent brigades.

THE GREEKS OUTGENERALED. LONDON, April 26.-The dispatches of the special correspondents for publica-tion to-morrow consist, for the most part, of additional details of the Greeks disof additional details of the Greeks dis-comfiture. The Turkish plans are not yet revealed. There is no doubt now that the Crown Prince Constantine or-dered the bridges to be destroyed before the Greeks abandoned Larissa, but damage could not be done beyond what could be easily repaired by the Turks. LONDON, April 26.-The correspondent of the Times at Larissa, telegraphing from that point Sunday evening, says: "The town was occupied by the Turkish cavalry at 6 o'clock this morning, after a short skirmish. The Greek troops flee in a panic, and most of the civilians abandoned their residences. Grumbokoff Pasha, the inspector-general of artillery; Mustapha Matki Bey, the Sultan's aidede-camp, and Habit Bey, and Sufukah Bey entered the town with the cavalry. The Turks captured six large guns in the forts, and a mountain battery, with several prisoners, among them officers and all the military stores. Edhen Pasha prohibited any piliaging, and there have been neither massacres nor outrages, though some of the Greeks burned their houses. The dead are not numerous. The Turks maintain excellent discipline. The Greek army fled to the mountain sides. Many of the inhabitants are already returning.

"At this moment (6 P. M.) the Ottoman troops are entering the town in triumph, with bands playing and banners waving. Mustapha Matki Bey has waving. effusiveness. The latter gave him coffee and cigarettes, and sent him to get food.

A TREMENDOUS EXPLOSION.

Panle on Underground Rallway, London-Many Persons Hurt. LONDON, April 26 .- A tremendous ex-

losion occurred on the underground rail way at 5:30 o'clock this evening, as a way at 5:39 o clock this evening, as a train filled with men from the city was making its usual stop at the Aldersgate station. The glass roof of the station was blown out. Many of the gas-lights in the waiting-rooms and on the platform were extinguished. A general panic ensued. When comparative quiet had been restored, it was found that a first-class coach had been completely wrecked, and that its occupants were lying about maimed and bleeding. Ten of the injured were found to be in a precarious condition, and were removed to hospitals. A number of persons who were standing on the platform were also hurt. Much of the wreckage was hurled across the station.

The cause of the explosion is not known, but it is believed to have been the result of an accumulation of gas, which became ignited in some way. Many persons, however, believe that the disaster was not due to accident, but was caused by the explosion of a bomb which had been placed in the station, with the intention of wrecking it. train filled with men from the city was of wrecking it. Mr. Caskie, who seconded the nomina-tion of Mr. Epps, made a strong appeal in behalf of that gentleman. He said that the report that Captain Epps had left about \$49,000 of life-insurance, be-sides yeluable property here and elsesides valuable property here and else-where, was erroneous, Mr. Caskle add-ed that the total amount of Captain Epps's insurance would not exceed \$4.690 or \$5,000, and his whole estate would hardly reach \$15,000 to \$16,000, although he ly reach \$15,000 to \$15,000, atthough he had held for many years a very remuerative office. Dr. Hunter McGuire was telegraphed for this morning, owing to the fact that Colonel Mosby appeared to be worse than he had been at any time since the accident of Friday last. Jr., of Denver, Col.—were telegraphed to come on here, as those of the family now with him did not consider his condition as favorable as they had hoped that it would be by this time. To a Dispatch reporter Dr. McGuire said that while Colonel Mosby is very des-

perately wounded, and is extremely ill, he has a good chance for recovery, and all of his physicians and friends are hope-When asked to describe Colonel Mosby's wounds, Dr. McGuire said they consist of a fracture of the skull, the loss of an eye, and a contusion of the brain. The skull is fractured on the bony edge of the eye's orbit, and the bone leading to the nose and joining the cavity of that shattered. The ball of the eye which was removed several days ago was burs the force of the blow which caused the

injury. The contusion of the brain naturalis causes unconsciousness, but the sufferer recognized Dr. McGuire when he entered his room yesterday morning, and that leads the physician to hope that the brais

will recover from its injury.

Colonel Mosby is surrounded by high children, and they, assisted by the many friends of the gallant warrior, are doing all in their power to make him comfort able and in some measure alleviate his suffering. He is about sixty-eight years of age, though, and this will make against him and cause his recovery, if he does recover, to be slow.

Mr. W. Ben. Palmer, who was a lieu-tenant under Mosby, received a telegram yesterday morning from Captain R. Stringfellow Walker, in which he said: "Come at once. We fear the worse for our noble chief." Mr. Palmer left for Charlottesville on the first train, and telegraphed back late in the afternoon that, while Colonel Mosby was very ill, there was still hope for his recovery.
