NEW YORK, April 14.—The stock market resumed today its reactionary course, displaying weakness again in the afternoon, particularly in the steel and grain markets.

Steel prices were generally lower, with a few exceptions. The market for grain was unsettled, with wheat and corn showing some volatility.
