the heat, and a heavy piece of iron
struck Murphy, knocking him down and
cutting his leg with a deep gash and
breaking the small bones of his left hand.
He was taken to the County Hospital,
where he will be compelled to remain for
some time.

At about 10 o'clock the bell on the hill
struck several different numbers for the
burning of a small grocery store on Third
street near Mateo, belonging to M. E.
Agen. Both Mr. and Mrs. Agen were
away from home at the time of the fire,
and the first that was known of its occurrence was when it broke out through the
roof. The entire dwelling and its contents
were burned. There was but a small
amount of insurance on both, and the loss
was estimated at about \$2,500.

### AN INTERESTING LOCALITY.

The Respectable People Complain of the State of Affairs. The respectable people who live on Mateo street between Fifth and Cincinnati, complain in vigorous terms of the condition of things which prevails there, by reason of the bad behavior of a small gang of tough characters who have set-tled in that neighborhood. She had used, it is charged, vulgar and insulting language to two girls by the name of Morrison, who lived near her. Her neighbors describe this woman as a 'holy terror,' and say she has 'more husbands than the law allows.' In the evening Mrs. Radciffe's son-in-law took a hand in the scrape by making an assault, it is said, on the brother of the two Morrison girls, who is a youth of about 20 in ill health. The report given of the affair is that young Morrison was knocked up against a fence and menaced with a piece of iron, but before he was injured in any way a couple of by-standers rescued him. It was from this same neighborhood that the celebrated "Crazy Jane" who alternates drunkenness and insanity was taken a week or two ago and put into the County jail. She showed the harmless playfulness of her disposition while confined there by kicking all the plastering off of her room and smashing her bedstead. Another interesting character from the same block is Paul Myer, who was arrested last Saturday night for beating his wife in a fit of drunkenness. The people of the street say that they appear to be almost out of the jurisdiction of the police force and that they have to settle many of the rows which occur by their own exertions. The locality has a bad name and shows no sign of improving, much to the disgust of the respectable people who own property or live there.

Car Line.

A big change in street-car travel was Car Line.

A big change in street-car travel was made yesterday. Some nights ago connection was made with the two-horse line on South Spring street and the one-horse-track on North Spring street by the side of one of which sets of track a third rail had been laid as far as Temple street, so as to accommodate a broad-gauge car. The mode of travel as instituted is as follows: The two-horse cars bound north go straight down from South into North Spring street, instead of turning down First street on to Main as heretofore. Southbound the cars run as usual, and this now dispenses with waiting on the switch outside the Nadeau House and gives the two-horse run a complete double track from their Washington street terminus to the Temple block. A number of people bound for the S. P. depot waited in vain along First and Main streets yesterday, until, thinking that something had gone wrong, made inquiries and were informed of the change.

The car was being driven down San Fernando street and when near one of the railroad crossings a switch engine was noticed approaching. The engineer, who had noticed the teamster's mistake, applied the brakes and succeeded in stopping the locomotive when it was within three feet of the car.
