grantee, or its successors

in any manner given or derived by the said grantee, or his successors or assigns, within the period of six (6) months from the use of said pipe line and from or on account of the carriage of said gas, and within ten days after the time for filing the aforesaid statement it shall be the duty of the said grantee, his successors or assigns, to pay to the City Treasurer of the City of Los Angeles the aggregate sum of the said percentage of the gross annual receipts and annual receipts arising from the use, operation or possession of this franchise as hereinbefore provided. And any neglect, omission or refusal by said grantee, or his successors or assigns, to file the aforesaid verified statement, or to pay the said percentage of the said gross annual receipts and annual receipts as hereinbefore provided, shall ipso facto work a forfeiture of the franchise hereunder to the City of Los Angeles.

That any neglect, failure or refusal to comply with any of the conditions of this franchise shall thereupon immediately ipso facto effect forfeiture thereof, and the said city, its City Council, may thereupon declare the franchise null and void, and include said grantee and its successors and assigns from further use of the streets of said city under said franchise and said grantee and its successors and assigns shall thereupon and immediately surrender all rights in and to the same, and this franchise shall be deemed and shall remain null, void and of no effect, and the said city, its said grantee, its successors or assigns shall have the right to remove said pipes from said streets, subject to such regulations as the said City Council may impose.

That said grantee, or its successors or assigns, shall not sell, transfer, lease, convey, or otherwise dispose of the rights or privileges granted hereby except by a duly executed instrument in writing, filed in the office of the clerk of the City of Los Angeles, and provided further, that nothing in said franchise contained shall be construed to grant to said grantee, or its successors or assigns, any right to sell, transfer, lease, convey, or otherwise dispose of the rights or privileges thereby granted, except in the manner aforesaid.

That the City of Los Angeles shall have the right, at the expiration of the aforesaid period, to purchase the pipelines and all properties in any of the streets hereinbefore mentioned, and to use the same as public franchise.

His or its successors in interest, laid out and constructed under the grant of said franchise, or used by said grantee or its successors in interest, for the exercise of said franchise, at a fair valuation, provided that the option to make such purchase shall be declared in writing by the said City Council not more than six months prior to the expiration of said period of twenty-one years.

option to purchase said property. If the case said arbitrators fail to make an award within the time hereinbefore specified, a new board of three arbitrators shall be appointed in the same manner as hereinbefore prescribed, to determine the valuation of said property. Immediately upon the appointment of its members enter upon the discharge of its duties. Any vacancy in the board of arbitrators shall be filled by the parties who made the original appointment to the vacant place. The award of the arbitrators must be made and filed with the City Clerk of said city within the time specified in the appointment, and a majority of the arbitrators who agree thereto may make such award.

That any neglect, failure or refusal to comply with any of the conditions of said franchise shall thereupon immediately ipso facto effect a forfeiture of the same.
