

NEARLY READY FOR ELECTION

Vote on Capitol Proposition Will Be Small—Judges Are Secured.

C. V. Anderson, custodian of the voting nachines, yesterday shipped twenty of he voting machines to the districts farthest from the city and county building, and will send the others out today. The machines are all ready for the election next Tuesday, June 8, when the proposiion of adding one mill to the tax levy tion of adding one mill to the tax levy to provide for a capitol which will be a credit to the state will be voted upon. The machines are so arranged that each voter on entering must vote before he or she can leave the booth. A further improvement over last fall made by Mr. Anderson is that it is only necessary to place the pointer in position on the "Yes" or "No," and pull back the bar. The releasing knob need not be touched, and all party levers are out of sight and locked.

Governor William Spry says he has received advices from various parts of the state that indicate the people generally are in favor of the scheme and that the general desire is that Utah shall have a capitol building worthy of her.

ballots.
In Salt Lake county nearly all of the judges have been secured after some difficulty. To save trouble the county commissioners decided to use the list of judges for the election last fall. This did not work well, many of these judges failing to qualify. There was not any general anxiety to act and some trouble was experienced in many districts in securing qualified taxpayers to act. There are still a few blanks which will be filled today.

Judges of election must be qualified voters, and qualified voters are only those who paid taxes in 1908. In case of a married couple paying taxes on real estate, only the party in whose name the tax receipt was issued may vote.

Qualified electors having moved from their old district must present a transfer from the registration agent of the district where he or she was last registered. The remuneration of the judges is but it a day. The conditions prevailing at the polling places are the same as in any other election.

It will probably be some days before the result of the election is known. Returns are made to the county commissioners, and canvassed by them. These report to the secretary of state, who canvasses the total vote. The vote in the larger cities and towns will be in by Tuesday evening but outlying districts will not be known for some days.

STOCKADE CASE GOES TO THE DISTRICT COURT

Another feature which will tend to prolong the stockade cases—a move the defense seems to have sought ever since the beginning of the various cases—came to light yesterday in the proceedings against the Citizens' Investment company, charged with owning property used for immoral enterprises, before Justice of the Peace Stanley A. Hanks.

The property referred to was designated as lot 6, block 64, in the precinct known as the stockade, and utilized as the disorderly house from which one of the prisoners, Margaret Smith, was taken.

At the conclusion of testimony, Justice Hanks discovered that the particular case came within the limitations of the category known as "indictable misdemeanknown as "indictable misdemean gory known as "indictable misdemean ors," the penalty for such a charge being from \$1,000 to \$10,000, while the limitation of his rulings came within a penalty o \$300. He said he had, no jurisdiction in a ccase of that kind, and it was therefore transferred to the district court. The prosecution was represented by P. T. Farnsworth, while Samuel King and C. L. King represented the defense.




