It is not often that an event is of equal interest to society and to musicians. Clubdom and art are by no means synonyomus terms, and the social events of the elite do not ordinarily stir ripples in the life of artists. What the Bohemian club does is, however, different, and the announcement of its annual concert, following the presentation of its yearly grove play in Sonoma county, is always an occurrence of even more than local interest, for the activities of the club in music have attracted the attention of musicians everywhere, and the mid-summer jinks music is a factor in the art life of the west which has excited comment and approval from the wise men of Berlin and the dramatic composers of Paris.

Fitzpatrick, representing Mrs. Langley, time to determine whether he would submit a defense.

Fitzpatrick said that although it was not customary to put the defendant on the stand at a preliminary hearing, he was willing that she should repeat the story she told the coroner and grand jury.

Sol Gutmann said that he had been drinking with Langley the day of the shooting, and although he did not care to take a hand in the matter, he remonstrated with Langley for his treatment of the child wife.

"Langley pushed her away ten or twelve feet just before she shot," said Gutmann, "and I yelled at him and told him to quit. I asked him to stop treating her that way and go home with her."
