THE FUGITIVE SLAVE LAW.

An Act to amend and supplementary to the act enti-tled "An act respecting fugitives from justice and persons escaping from the service of their masters," approved February twelfth, one thousand seven

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the persons who have been or may hereafter be appointed commissioners in virtue of any act of Congress, by the circuit courts of the United States, and who, in consequence of such appointment, are authorized to exercise the powers that any justice of the peace, or other magistrate of any of the United States, may exercise in respect to offenders for any crime or offence against the United States, by arresting, imprisoning, or bailing, the same, under and by virtue of the thirty-third section of the act of the twenty-fourth of September, seventeen hundred and eightynine, entitled "An act to establish the judicial courts of the United States," shall be, and are hereby, authorized and required to exercise and discharge all the powers and duties conferred by this act.

SEC. 2. And be it further enacted, That the superior court of each organized Territory of the United States shall have the same power to appoint commissioners to take acknowledgments of bail and affidavits, and to take depositions of witnesses in civil causes, which is now possessed by the circuit court of the United States; and all commissioners who shall bereafter be appointed for such purposes by the superior court of any organized Territory of the United States, shall possess all the powers, and exercise all the duties, couferred by law upon commissioners appointed by the United States for similar purposes, and shall moreover exercise and discharge all the powers and duties con-

ferred by this act.
SEC. 3. And be it further enacted, That the circuit courts of the United States, and the superior courts of each organized Territory of the United States, shall from time to time enlarge the number of commissioners, with a view to afford reasona-ble facilities to reclaim fugitives from labor, and to the prompt discharge of the duties

SEC. 4. And be it further enacted, That the commissioners above named shall have concurrent jurisdiction with the judges of the circuit and district courts of the United States in their respective circuits and districts within the several States, and the judges of the superior courts of the Territories, severally and collectively, in termtime and vacation; and shall grant certificates to such claimants, upon satisfactory proof being made, with authority to take and remove such fugitives from service or labor, under the restrictions herein contained, to the State or Territory from which such persons may have escaped or

SEC. 5. And be it further enacted, That it shall be the duty of all marshals and deputy marshals to obey and execute all warrants and precepts issued under the provisions of this act, when to them directed; and should any marshal or deputy marshal refuse to receive such warrant or fined in the sum of one thousand dollars. to the use of such claimant, on the motion of such claimant, by the circuit or district court for the district of such marshal; and after arrest of such fugitive by such marshal or his deputy, or whilst at any time in his custody under the provisions under this act, should such fugitive escape, whether with or without the assent of such marshal or his deputy, such marshal shall be liable on his official bond to be prosecuted for the benefit of such claimant for the full value of the service or labor of said fugitive, in the State, Territory, or District, whence he escaped; and the better to enappointed, to execute their duties faithfully and efficiently, in conformity with the requirements of the Constitution of the United States and of this act, they are hereby authorized and empowered, within their counties, respectively, to appoint, in writing, under their hands. any one or more suitable persons, from time to time, to execute all such warrants and other process as may be issued by them in the lawful performance of their respective duties; with authority to missioners, or the persons to appointed by them, to execute process as aforesaid, to summon and call to their aid the bystanders, or posse comitatus of the proper county, when necessary to insure a faithful observance of the clause of the Constitution referred to, in conformity with the provisions of this act; and all good citizens are hereby commanded to aid and assist in the prompt and efficient execution of this law, whenever their services may be required, as aforesaid, for that purpose; and said warrants shall run and be executed by said officers anywhere in the State within which they are issued.

when a person held to service or labor in any State or Territory of the United States, has heretofore or shall hereafter escape into another State or Territory of the United States, the person or persons to whom such service or labor may be due, or his, her, or their agent or attorney, duly authorized by power of attorney, in writing, acknowledged and certified under the seal of some legal officer or court of the State or Territory in which the same may be executed, may pursue and reclaim such fugitive person, either by procuring a warrant from some one of the courts, judges, or commissioners aforesaid, of the proper circuit, district, or county, for the appre-hension of such fugitive from service or labor, or by seizing and arresting such fu-gitive, where the same can be done with-out process, and by taking, or causing such person to be taken, forthwith before such court, judge, or commissioner, whose luty it shall be to hear and determine the case of such claimant in a summary man-ner; and upon satisfactory proof being ade, by deposition or affidavit, in wri-

tified by some court, magistrate, justice of the peace, or other legal officer authorized to administer an oath and take depositions under the laws of the State or Territory from which such person owing service or labor may have escaped, with a certificate of such magistrate or other authority, as aforesaid, with the seal of the proper court or officer thereto attached, which seal shall be sufficient to establish the competency of the proof, and with proof, also by affidavit, of the identity of the person

whose service or labor is claimed to be due, as aforesaid, that the person so ar-rested does in fact owe service or labor to the person or persons claiming him or her, in the State or Territory from which such fugitive may have escaped as aforesaid and that said person escaped, to make out and deliver to such claimant, his or her agent or attorney, a certificate setting forth the substantial facts as to the service or labor due from such fugitive to the claimant, and of his or her escape from the State or Territory in which such service or labor was due, to the State or Territory in which he or she was arrested, with authority to such claimant, or his or her agent or attorney, to use such reasonable force and restraint as may be necessary, under the circumstances of the case, to take and remove such fugitive person back to the State or Territory whence he or she may have escaped as aforesaid. In no trial or hearing, under this act, shall the testimony of such alleged fugitive be admitted in evidence; and the certificates in this and the first section mentioned shall be conclusive of the right of the person or persons in whose favor granted, to remove such fugitive to the State or Territory from which he escaped, and shall prevent all molestation of such person or persons, by any process issued by any court, judge, magistrate, or other person, whomsoever.

Sec. 7. And be it further enacted, That

any person who shall knowingly and will-

ingly obstruct, hinder, or prevent such claimant, his agent or attorney, or any person or persons lawfully assisting him her, or them, from arresting such a fugi-tive from service or labor, either with or without process as aforesaid; or shall rescue or attempt to rescue such fugitive from service or labor, from the custody of such claimant, his or her agent or attorney, or other person or persons lawfully assisting as aforesaid, when so arrested, pursuan to the authority herein given and declared or shall aid, abet, or assist such person so owing service or labor as aforesaid, directly or indirectly, to escape from such claimant, his agent or attorney, or other person or persons legally authorized as aforesaid : or shall harbor or conceal such fugitive, so as to prevent the discovery and arrest of such person, after notice or knowledge of the fact that such person was a fugitive from service or labor as aforesaid, shall for either of said offences, be subject to a fine not exceeding one thousand dollars, and imprisonment not exceeding six months, by indictment and conviction before the district court of the United States for the district in which such offence may have been committed, or before the proper court of criminal jurisdiction, if committed within any one of the organized Territories of the United States; and shall moreover forfeit and pay, by way of civil damages to the party injured by such illegal other process when tendered, or to use all conduct, the sum of one thousand dollars proper means diligently to execute the for each fugitive so lost as aforesaid, to be same, he shall, on conviction thereof, be recovered by action of debt, in any of the district or territorial courts aforesaid, within

And be it further enacted, That the marshals, and their deputies, and the clerks of the said district and territorial courts, shall be paid for their services the like fees as may be allowed to them for similar services in other cases; and where such services are rendered exclusively in the arrest, custody, and delivery of the fugitive to the claimant, his or her agent or attorney, or where such supposed fugi-tive may be discharged out of custody for the want of sufficient proof as aforesaid able the said commissioners, when thus then such fees are to be paid in the whole by such claimant, his agent or attorney and in all cases where the proceedings are before a commissioner, he shall b entitled to a fee of ten dollars in full for his services in each case, upon the delivery of the said certificate to the claimant, his or her agent or attorney; or a fee of five dollars in cases where the proof shall not, in the opinion of such commissioner, warrant such certificate and delivery, inclusive of all services incident to such arrest and examination, to be paid in either case by the claimant, his or her agent or attorney. The person or persons authorized to execute the process to be issued by such commissioners, for the arrest and detention of fugitives from service or labor as aforesaid, shall also be entitled to a fee of five dollars each for each person he or they may arrest and take before any such commissioner as aforesaid, at the instance and request of such claimant; with such other fees as may be deemed reasonable by such commissioner for such other additional services as may be necessarily performed by him or them; such as at tending at the examination, keeping the fugitive in custody, and providing him with food and lodging during his detention, and until the final determination of such commissioner; and in general for performing such other duties as may be required by such claimant, his or her attorney or agent, or commissioner in the premise such fees to be made up in conformity with the fees usually charged by the officers of the courts of justice within the

And be it further enacted, That when any person held to service or labor in any State or Territory, or in the District of Columbia, shall escape therefrom, the may apply to any court of record therein or judge thereof in vacation, and make satisfactory proof to such court, or judge in vacation, of the escape aforesaid, and description of the person so escaping, with such convenient certainty as may be and a transcript of such record, authenticated by the attestation of the clerk and of the seal of the said court, being produced in any other State, Territory, or District, in which the person so escaping may be found, and being exhibited to any judge, commissioner, or other officer authorized by the law of the United States subject of Slavery and the extradition of to cause persons escaping from service or labor to be delivered up, shall be held and taken to be full and conclusive evidence of the fact of escape, and that the service or labor of the person escaping is due to the party in such record mentioned. And upon the production by the said party of other and further evidence, if necessary either oral or by affidavit, in addition to what is contained in the said record, of the identity of the person escaping, he or cred trust for the benefit of the people, she shall be delivered up to the claimant. And the said court, commissioner, judge or other person authorized by this act to grant certificates to claimants of fugitives shall, upon the production of the record and other evidences aforesaid, grant to to be owing service or labor as aforesaid which certificate shall authorize such claimant to seize or arrest, and transport such person to the State or Territory from which he escaped; Provided, That noth ing herein contained shall be construed as requiring the production of a transcript of such record as evidence as aforesaid But in its absence, the claim shall be heard and determined upon other satisfactory proofs, competent in law.

INDEPENDENT DEMOCRATIC PLATFORM. ADOPTED AT PITTSBURGH, AUGUST 12, 1852

Having assembled in National Conven tion as the delegates of the Free Democracy of the United States, united by a common resolve to maintain right against fiding in the intelligence, patriotism, and the discriminating justice of the American people; putting our trust in God for the triumph of our cause, and invoking his guidance in our endeavors to advance it, we now submit to the candid judgment of all men the following declaration of principles and measures:

I. That Governments, deriving their just powers from the consent of the governed, are instituted among men to secure to all, those inalienable rights of life, liberty, and the pursuit of happiness, with which they were endowed by their Creator, and of which none can be deprived by valid legis-

lation, except for crime.

II. That the true mission of American Democracy is to maintain the liberties of the people, the sovereignty of the States, and the perpetuity of the Union, by the impartial application to public affairs, without sectional discriminations, of the fundamental principles of equal rights, strict justice, and economical administration.

III. That the Federal Government i one of limited powers, derived solely from the Constitution; and the grants of power therein ought to be strictly construed by all the departments and agents of the Government, and it is inexpedient and dan-gerous to exercise doubtful constitutional

IV. That the Constitution of the United States, ordained to form a more perfect union, to establish justice, and secure the blessings of liberty, expressly denies to the General Government all power to deprive any person of life, liberty, or property, without due process of law; and, erty, without due process of law; and therefore, the Government, having no more power to make a slave than to make king, and no more power to establish slavery than to establish monarchy, should at once proceed to relieve itself from all responsibility for the existence of slavery wherever it possesses constitutional power to legislate for its extinction.

V. That, to the persevering and impor more slave States, new slave Territories, and the nationalization of Slavery, our dis tinct and final answer is-no more slave States, no slave Territory, no nationalized Slavery, and no national legislation for the

extradition of slaves. VI. That Slavery is a sin against God and a crime against man, which no human enactment nor usage can make right; and that Christianity, humanity, and patriotism, alike demand its abolition.

VII. That the fugitive Slave Act of 1850 is repugnant to the Constitution, to the principles of the common law, to the spirit of Christianity, and to the sentiments of the civilized world. We therefore deny its binding force upon the American People, and demand its imme-

XX. That the Free Democratic party not organized to aid either the Whig or Democratic wing of the great Slave Compromise party of the nation, but to defeat them both; and that repudiating and renouncing both, as hopelessly corrupt, and utterly unworthy of confidence, the purpose of the Free Democracy is to take possession of the Federal Government, and administer it for the better protection of the rights and interests of the whole

people.

XXI. That we inscribe on our banner FREE SOIL, FREE SPEECH, FREE LABOR, and FREE MEN, and under it will fight on and fight ever, until a triumphant victory shall reward our exertions.

That our mission as a Republic is not to propagate our opinions, or impose on other countries our form of government, by artifice or force, but to teach by example, and show by our success, moderation, and justice, the blessings of self-government and the advantages of free institutions.

IV. That where the people make and control the Government, they should obey its constitution, laws, and treaties, as they would retain their self-respect, and the respect which they claim and will enforce

from foreign powers. V. Government should be conducted upon principles of the strictest economy, and revenue sufficient for the expenses thereof, in time of peace, ought to be mainly derived from a duty on imports, and not from direct taxes; and, in levying such duties, sound policy requires a just discrimination and protection from fraud by specific duties, when practicable, whereby suitable encouragement may be assured to American industry, equally to all classes and to all portions of the coun-

VI. The Constitution vests in Congress the power to open and repair harbors, and remove obstructions from navigable rivers; and it is expedient that Congress shall exercise that power whenever such improve-ments are necessary for the common defence or for the protection and facility of com-merce with foreign nations or among the States; such improvements being, in every instance, national and general in their character.

VII. The Federal and State Governments are parts of one system, alike ne-cessary for the common prosperity, peace, and security, and ought to be regarded alike with a cordial, habitual, and immovable attachment. Respect for the authority of each, and acquiescence in the constitutional measures of each, are duties required by the plainest considerations of

National, of State, and individual welfare. VIII. The series of acts of the 31st Congress, commonly known as the Compromise or Adjustment, (the act for the recovery of fugitives from labor included,) are received and acquiesced in by the Whigs of the United States as a final settlement, in principle and substance, of the subjects to which they relate; and so far

as these acts are concerned, we will maintain them, and insist on their strict en-forcement, until time and experience shall demonstrate the necessity of further legissentatives until the judgme.
