Pursuant to adjournment, at 5:10 o'clock p. m., a much later hour than that appointed, Chairman Crist sounded his gavel and called the Territorial democratic convention to order to hear the reports of the committees on credentials, resolutions and permanent organization.

The first report was on credentials; the second on permanent organization and rules; the third report on resolutions.

The report of the committee on credentials was received and adopted without amendment and the delegates named in it declared to be entitled to seats in the convention.

Next came the report of the committee on permanent organization and rules. Hon. H. B. Ferguson was named as president of this convention, H. J. Hill as secretary, and as interpreter, Antonio L. Lopez and Manuel Sizeros. The report recommended the following: That the committee on resolutions should report; that six delegates and six alternates be chosen to represent New Mexico at the national democratic convention at Chicago; that a free silver plank be inserted in the platform.

The officers mentioned in the report were then escorted to the platform and, as well, a vice-president from each county, who was selected by his delegation.

H. B. Ferguson was then introduced by Chairman Crist and spoke at length on the duty of all good democrats to obey the will of the majority and stand by the party through all its battles for political supremacy.

The next business of the convention was receiving the report of the committee on resolutions and rules, which report was as follows:

MR. CHAIRMAN:—Your committee on resolutions beg to submit the following: The democratic party of the Territory of New Mexico, in convention assembled at Las Vegas, New Mexico, June 10th, 1896, re-affirms its allegiance to the time-honored principles of said party, and resolves as follows:

First.—That we are in favor of the free and unlimited coinage of silver and gold, independent of the action of foreign nations, at the ratio of 16 to 1, as the same existed prior to its demonetization by the republican party in 1873, and we hereby instruct our delegates to the national convention to support no man for president of the United States, or any platform which is not in faithful accord with these principles, and we further instruct said delegates to vote as a unit on this proposition.

Second.—It is the sense of this convention that a proper and just method of raising a portion of the revenue necessary for the running of this national government is by increasing the tax on the liquor traffic, and it now exists in not consistent with an income tax that we are in favor of such an amendment to the same as will be consistent with the legality of such tax.

Third.—We are in favor of a tariff for revenue for the maintenance of our government economically administered, and that in levying said tax it should be by discriminating in favor of taxing those articles that will be in the interests of the masses of the people without the danger of fostering monopolies.

Fourth.—Recognizing his true democratic, worthy and faithful adherence under all circumstances to the cause of the masses, and especially his courageous, consistent and unswerving fight for the past twenty years for the free coinage of silver, we do hereby most heartily endorse Richard P. Bland as a candidate for president, at the national democratic convention at Chicago on July 17th, 1896.

Fifth.—We approve the able, active, vigorous and incessant efforts of our Governor, W. T. Thornton, and our Secretary, Lorton Miller, and our Chief Justice, Hon. Thomas Smith, and the Associate Justices, the Honorable N. B. Laughlin, N. C. Collier, H. B. Hamilton and G. D. Bantz, and all other executive officers of this territory in the suppression of crime and in the upholding and maintaining of law and order in this territory.

Sixth.—We most strongly condemn those who, by their actions as congressmen, have held up the people of this nation to the scorn and ridicule of the nation; and especially do we denounce him for his failure to do more as delegate from this territory than to provide sinecure for members of his own family.

Seventh.—That we denounce the reprehensible and cowardly evasion by the republican party of New Mexico, in the convention assembled, of the silver question and other vital issues before the people.

Eighth.—That we are in favor of personal liberty and religious freedom, and believe that every citizen of this republic has an absolute right to any office without the gift of the people, and we condemn and denounce as un-American and contrary to a democratic form of government the secret organization known as the A. P. A., the members of which are pledged to prevent the election to public office of any American citizen of the Catholic faith.

The motion made and seconded to adopt the resolutions as read, provoked considerable discussion, and much speech-making was indulged in, but finally carried almost unanimously, and the meeting then adjourned till 7:30 o'clock.

At this point (6:10 o'clock) in the proceedings, THE OPTIC, containing a full report of the business of the convention, up to the adjournment at 4 p. m., was brought in, and eagerly sought by all parties desirous of reading the new sheet.

8:30 p. m.—Meeting called to order by President H. B. Ferguson, who stated that nominations would now be in order for delegates to the Chicago convention. The following were the nominees by counties: Demetrio Chavez, of Dona Ana; M. M. Salazar, of Colfax; W. S. Hopewell, of Sierra; John Y. Hewitt, of Lincoln; Antonio Joseph, of Rio Arriba; A. A. Jones, of San Miguel.

On motion, made and carried unanimously, that roll-call of counties be now stopped, nominations closed, and that the six gentlemen named be selected as delegates to the Chicago convention.

It was now moved that a committee of five be appointed by the chair to present the names of six gentlemen as alternates to the Chicago convention, and the alternates chosen by such committee were: For M. M. Salazar, F. S. Croswell; for A. A. Jones, J. W. Zullars; for A. Joseph, R. Martinez; for J. Y. Hewitt, J. G. Fitch; for W. S. Hopewell, J. G. Fitch; for D. Chavez, H. L. Warren.

On motion of a Bernalillo county delegate, the Hon. H. B. Ferguson was thanked for the able manner in which he had presided at this convention, and for his energetic advocacy of democracy.

Next order of business was the nomination of a national committee man, and Mr. Felix Martinez in an extremely felicitous speech placed in nomination the name of the Hon. F. A. Manzanares, which was received with rounds of applause. The delegates chosen were recommended to support him as the choice of the convention.

Motion thanking the city of Las Vegas for its hospitality, was then made and carried unanimously.

It was now moved and carried that three cheers be given for free silver, and the sense of the motion heartily responded to, after which the convention adjourned.
