SENATOR ALLEN PROTESTS AGAINST EASTERN CRITICISM.

SAYS POPULISTS ARE HONEST.

HAVE NO INTENTION OF DEFRAUD-ING THEIR CREDITORS.

In Nebraska, at Least, There Is No Danger of Legislation Hostile to Capital-Peffer Puts in a Word for Kansas-Con-

Washington, Dec. 14.-The final rote on the immigration bill will be taken in the senate next Thursday at 4 p. m., according to an agreement reached to-day. Little doubt is entertained as to the passage of the measure, and as it already has passed the house it will be in conference before

In the course of Mr. Allen's remarks, he paid a tered glowing tribute to William J. Bryan as states, not political parties. "Nebraska," said he, in reply to this, "has directly within the true province of a Christian government.

"Massachusetts possesses nothing in Ne-braska that should entitle her foremost man to speak of our people as the senior sensior from that state has done. While we accord to Massachusetts her rights, and look upon her as an older, and therefore more complete and better organized, community than ours, we do not look to her for advice on political, social, scientific, retious or any other question.
"I do not speak of this misrepresentation

as strongly as I feel, but I must be permitted to say that it was an unwarranted, gratuitous, open and flagrant insult to an onest, intelligent, poor but struggling Christian people. The percentage of illiteracy in Nebraska is smaller than in Massachusetts. Her churches and schools, ac cording to her population, are fully as numerous and as well equipped to impart Christian and secular education as are those of Massachusetts. Our charitable in feal, honest, intelligent, persevering and

It cannot be truthfully said of Nebraska that she joined in a crazy and dishonorm-ble crusade to enforce the provisions of a brutal fugitive slave law. Her people have never been guilty of mobbing one of their own citizens for no greater offense than raising his voice against eppression and wrong. The stillness of her atmosphere has not been broken by the appeals for assistance of cringing men and defenseless women and children, guilty of no offens, captured and placed in chains for a re-

Whatever may be said of Nebrasky she has not been guilty of any of these crimes against the laws of God and civilization. She has never dishonored her foremost edizen, when living for extelling the carse of liberty, and placed wreaths on his grave, when dead, because he had beer the friend of liberty. She had done none of these, and no dishonor of this kind ates to her name or imperils her giory,"

Mr. Allen said that he understood perectly that there were those who had been born and lived in Massachusetts who had conceived a most bitter hatred for the West and everything Western, and who be-lieved that neither good nor intelligence could be found in that section of the country, but he declared that the patriotism of the people of Nebraska was as broad and mitless as her plains; their Christianity and sense of duty as pure and untainted as her atmosphere. Never thus far in the distory of the state had she been guilty of lishonor, and never as long as intelligence should be predominant and God should reign in the hearts of her people would she be guilty of anything that would place a

KANSAS POPS LOOKING OUT FOR THEIR RELATIVES.

OUTSIDERS RISING IN MUTINY.

NEPOTISM AS RANK AS UNDER THE LEWELLING REGIME.

Mr. Leedy Heads Off by Slating Four Relatives for Jobs-Perfection of the Nepotism System Under Lewelling-Kansas Political News.

Topeka, Kas., Dec. 14.-(Special.) Dark clouds are already hovering over the Populist outfit in Kansas. There is mutiny in camp. A factor that rendered material assistance in the overthrow of the "first People's party government on earth" has again arisen and threatens to disrupt the party completely. That factor is nepotism.

Despite the fact that one of the cardinal principles of Populism is opposition to favoritism of relatives, yet the members of the incoming administration threaten to follow the footsteps of the Lewelling administration and keep all the offices among their relatives. This question caused more dissatisfaction among the Populists during the Lewelling regime than all other things combined-not even the rottenness excepted. Nepotism was practiced in every branch of the state government. No oncould get a subordinate place until the relatives of the heads of the various de partments were taken care of. Then, if anything was left, the outsiders were given

Failing to profit by the experience of the former Populist administration, some of the state officers-elect have given it out that they propose to take care of their relatives first and outsiders after. It is stated in Populist stated in Populist circles that Treasurer elect Hefflebower has decided to put two members of his family in his office, and that the other state officers will provide places for one or more relatives. Governor-elect Leedy has already given his niece a place. There is little objection to that, for she is thoroughly competent and deserves the place; but the ple hunters say he will not stop there. At least three other relatives of his are said to be slated, and they fear even more. It seems that every person who is related to the state officerselect as far back as the fourth cousins-in law are after jobs, and that the only valid claim for places is relationship.

This recent uprising of relatives has thrown the ple hunters into a state of threatened rebellion. As a rule, each of the 2,500 or more place hunters is at the head of some faction in his particular neighborhood and is a "power in politics." They all believe that they are entitled to something, and the report that all relatives will first be taken care of has thoroughly aroused them. Notice has been served on the officers-elect that they will make a fatal mistake by appointing rel-atives. It is not expected that any attention will be paid to the notice, howa day of reckoning which will be regretted

CRAZY DEED OF AN ITALIAN.

BEAT HIS FATHER'S BRAINS OUT WITH A CLUB.

Took Refuge in a Cellar and Was Taken Only After a Terrible Struggle - Family Victims of Religious Frenzy.

New York, Dec. 14.-At Vineland, N. J., this afternoon, a crowd of armed men battered down the door of the home of Luigi Jurio, cut through the cellar, and, after a terrific struggle, captured Antonio Jurio. who had brutally murdered his father. In the cellar with the murderer were his mother and brother, all insane with religious frenzy

Until recently the Jurio famaly were liv ing happily, but the death of a younger son seemed to turn the minds of them all. Since that time they have been exhibiting religious frenzy constantly in all places, and a few weeks ago two of the sons, one of whom was Antonio, were arrested and sent to jail. They were discharged a day or two ago, and the father, Luigi Jurio. incurred the wrath of Antonio by refusing any longer to indulge in the insane and boisterous religious services,

Havana, Dec. 14.-The United States consulate general in this city is under a special guard of armed policemen.
