To the Citizens and the Voters of the 28th Criminal Judicial District:

I have filed my application for a place on the Democratic ticket, to be voted upon for District Attorney in the coming Primary Election. In so doing, it is my purpose only to undertake to strengthen the standard and integrity of that office. It is an important office, as it has to do with the life and liberty of people, and has for its purpose the preservation of the peace and dignity of the State and the people.

If I am elected, which I hope to be, it will be my purpose so far as the functions of the office is concerned to bring about a due and legal enforcement of our criminal laws. There is nothing smart, which I desire to do, but my guide in the prosecution of cases will be, First—Has there been an infraction of the law? Second—Is the available testimony strong enough to warrant a jury in a conviction and the Higher Courts in maintaining a verdict of guilty if such be written by the jury? I have no enemies to punish and no friends to reward from an official standpoint. Everybody will alike have a square deal, in so far, as I am able to give it to them, and I am running only my own campaign.

I feel that I am well equipped to take care of this office as it should be, having been county attorney in East Texas for six years, and district attorney for two years, having resigned the district's attorney office of the 4th Judicial District of Texas, at about the expiration of the term thereof, when I moved to Brownsville ten years ago. For over two years, I have been special Assistant U. S. District Attorney, and all in all, have written thousands of indictments. My record as an officer is before the lawyers and people of Texas and I am constrained to say, that my record in the higher courts will compare fairly well with any prosecuting attorney of Texas.

I was born and raised in this State, and before moving to Brownsville, lived in Pampa County, where I was born. The 4th Judicial District of the State, of which I was District Attorney comprised the counties of Pampa, Harrison, Gregg and Rusk; and as to my life, as a citizen and an officer, before coming to Brownsville, I would gladly refer any one to the people and officers of any of the above named counties.

I have stood for the emancipation of woman to the end that she might be accorded the right to vote if she wished, and it will be my purpose to still stand for this right for her as long as it is necessary. It was my privilege and honor to nominate one of the ladies who went as a delegate to the National Convention just held. I therefore, solicit the support of all citizens and voters in the coming primary, and if elected, will faithfully perform the duties of that office as I understand them.
