RUSSIAN NEWS WEAKENS TONE

Steel Issues Yield in Initial Trading and Rail Stocks Are Weak.

NEW YORK, Feb. 20.—The irregularity which marked the early trading in stocks was again manifest in the closing hour. Despite heavy profit-taking prices held remarkably well. Some influential sources were inclined to pick up the steel issues near the close. Studebaker shared in the general trading, but did not show the buoyancy of yesterday.

RECOVERY COMES SOON.

After the first 15 minutes of business, however, recoveries were in order, with many stocks selling higher than yesterday's closing prices. Baldwin rose to 81 and Steel Common rallied to above 97. Marine Preferred sold up to 100 and General Motors rallied two points from the low.

There was a good deal of irregularity during the forenoon. Selling was pronounced during the first hour when losses of 1 to 3 points were sustained in leading issues, but following these declines there was brisk demands. Baldwin gained 2 points from its low to 81, 1-4, but then dropped to 79 1-4. Most of the other steel industrials moved in about the same way.
