

Disaffected Senators Satisfied with

SUGAR SCHEDULE AND INCOME TAX

the Revised Tariff Bill.

An Ad Valorem Instead of Specific Duty on Sugar and a Time Limit for the Enforcement of the Income Tax-The Bill May Pass by July 1.

WASHINGTON, April 27.—The principal changes to be made in the tariff bill in accordance with the agreement made by the Democratic senators are in the income tax and the sugar schedule. The sugar men have been from the first clamorous for an ad valorem instead of a specific duty, and that change has been conceded. The de-tails have not been absolutely fixed, but there is little doubt, if any, that the sugar schedule will be entirely supplanted by a new one, which will provide a uniform duty of 40 per cent. ad valorem, with an addition of one-eighth of a cent for reflued

The principal change in the income tax ts a provision for the limitation of the time that the law shall remain in opera-tion. This is another matter of detail which has not been absolutely agreed upon, but the principle having been con-ceded the senators who have the compromise in hand do not consider that there is any possibility of failure on account of the period. It will probably be about five or six years. There will be no change in the rate of taxation, which will be left at 2 per cent. on amounts in excess of \$4,000. Some changes will take place in the ad-ministrative features of the bill, and some of them look towards the equalization of the tax, so as to make it bear alike upon

all classes which it may effect.

A number of changes in the rate of duty will be made in the iron schedule, in which there will be a slight advance over the rates fixed by the pending bill. Carpets will also secure an advance. In many cases the rates fixed in the house bill will replace those of the bill reported to the

senate by the finance committee.

Another material concession which will be made to the disaffected senators will be the restoration of the specific system in many places where the finance committee many places were the manor committee changed the house bill by the substitu-tion of ad valorem duties. The manufac-turers have made especial complaint of the ad valorem system because of the opportunity which they say it offers for fraud. Their senators have supported them in this representation, and the finance committee, while still retaining their confidence in the fairness of advalorem methods, have decided to yield the point in many instances for the sake of harmony and with the hope of securing the zealous

support of the united party in the senate.

There will be no change in the rates fixed on iron ore, lead ore or coal, and wool will remain on the free list. The whisky tax as reported by the finance cora-

mittee will also be undisturbed.

It is understood that the entire Democratic majority of the fluance committee is in hearty accord upon the wisdom of the proposed changes. Senator Jozes, of Arkansas, has taken the initiative and performed the greater part of the work of affection the compromise by getting the dissatisfied senators to state what they wanted and bringing them together, and also by securing the assent and co-operation of the president and Secretary Car-

The conservatives, with the one exception of Senator Hill, who is absent from the city, have been fully consulted at the various stages of the negotiation, and it is understood that, with the amendments added to the bill, it will receive their cordial support. They have given assurance to this effect, and those supposed to be authorized to speak for Schafor Hill say
