MINNESOTA SCHOOL FUND.

What the Auditor's Report Shows Regarding Its Collection and Investment.
 ST. PAUL, Feb. 19.—The state auditor's report for the years ending July 31, 1895, and July 31, 1894, will appear in book form in a few days. The state auditor estimates the taxable value of all property in the state for 1894, at \$650,000,000; that for the years 1895 and 1896 lists at \$660,000,000 and \$670,000,000 respectively.

"Owing to the heavy decrease on the gross earnings of our railroads," he continues, "the receipts from this source have fallen away since the end of the fiscal year 1893, but in the natural order of things this condition will be bettered. The estimated receipts from this source, as given in the table, are thought to be entirely within the bounds of probability."

The School Fund.

The report of the land department shows the school fund amounts to \$10,712,119.60 an increase of \$579,252.17 since the last report. The average price of all school lands sold is \$5.95 per acre. The permanent school fund will eventually amount to not less than \$20,000,000. The fund has already accumulated from the following sources:

Sales of land, \$8,690,443.45; amount paid on forfeitures, right of way, etc., \$117,505.74; sales of pine timber, \$1,578,056.70; mineral leases, \$83,575; royalty on iron ores, \$66,755.27; profits on sales of bonds, \$235,732.44; total, \$10,712,119.60.

How It is Invested.

The school funds in the state are invested as follows:

Cash, \$114,870.95; land contracts (including \$1,823,920.44 transferred, internal improvement land contracts) \$6,711,863.48; Minnesota funding bonds, 3 1/2 per cent, \$150,000 Tennessee settlement bonds, 3 per cent, \$1,673,650; Minnesota revenue bonds, 4 per cent, \$100,000; Minnesota building bonds, 4 per cent, \$150,000; Tennessee redemption bonds, 4 1/2 per cent, \$270,000; Alabama consols, series "A," 4 and 5 per cent, \$183,000; Alabama consols, series "B," 5 per cent, \$15,000; Alabama funding bonds, 4 per cent, \$105,737.50; school district and county bonds, 5 per cent, \$1,027,739.72.

ONLY FIVE PER CENT.

Decision of Importance to Holders of Minnesota State Land Contracts.

ST. PAUL, Feb. 18.—Attorney General Childs has given an opinion concerning the rate of interest that can be lawfully collected from the holders of delinquent state land contracts. He interprets the act of 1893 as relieving the holders of contracts drawing 7 per cent interest by requiring them to pay only 5 per cent interest.

This opinion is of considerable importance to the holders of delinquent contracts, purchased many years ago at a 7 per cent rate of interest. Heretofore they have been regularly paying 7 per cent interest, regardless of the act passed in 1893 reducing the interest to 5 per cent.

NEWS BRIEFLY REPORTED.

Archduke Albert of Austria died at Arco, South Tyrol, of congestion of the lungs, in his 78th year. He was the oldest son of Archduke Charles, a brother of the grandfather of Emperor Francis Joseph.

With the exception of John Wilde, an American, all the foreigners who were serving with the Chinese at Wei-Hai-Wei have been released by the Japs.

Fearful snow storms are prevailing along the Russo-Austrian frontier. The railroads are interrupted and many deaths have been caused by the extreme cold.

Cholera in Argentine.

WASHINGTON, Feb. 19.—The presence of cholera in Argentine has been formally recognized by the Argentine government, according to Consul Baker at Buenos Ayres, who has reported the fact to the state department, adding that he believes the disease is really the cholera morbus which appears there every year.

Mercury Goes to Formosa.

HONG KONG, Feb. 19.—The British cruiser Mercury has been suddenly dispatched from this port to the island of Formosa in response to an urgent appeal sent by the British consul there for the presence of a warship. The consul said the vessel was needed for the protection of foreigners. The Mercury is a cruiser of 3,000 tons and carries 13 guns.

Smallpox on Board.

SAN FRANCISCO, Feb. 19.—The steamship City of Sydney arrived from Panama and way ports and was ordered into quarantine by Dr. Lawler, the quarantine officer, because of smallpox which developed on one of the crew on the voyage up the coast.

Charged With Larceny.

FOND DU LAC, Wis., Feb. 19.—M. V. Sullivan, a prominent retired merchant, was arrested, charged with larceny by M. L. Collins, a former business partner. His residence was searched, and \$150 worth of articles found and identified by Collins as his own.


