FOUR INDICTED FOR SUGAR PROFITEERING

Fort Smith, Ark., June 16. — The federal grand jury here late today returned indictments against four local wholesale grocery houses on charges of violating the terms of the Lever act, the indictments charging that the defendants sold sugar at prices which brought an unreasonable profit.

In each indictment with the exception of one, the charge is made that sugar was purchased by the defendant at 12 1-2 cents a pound and sold at between 27 and 28 cents. The one exception, the indictment shows the defendant purchased sugar at about 27 cents.

The information states that more than 333,000 pounds of sugar were involved in the transaction.

On account of the increased cost of Labor and on materials used for operation, we are compelled to ask the Arkansas Corporation Commission for permission to increase the rates for various classes of service.

Present rates for resident phones \$1.50 wall phone; \$2.00 for Desk phone in the city limits.

Present rates for business phones is \$2.50 wall phones, and \$2.75 for desk phones per month.

Present rates for extension phones, wall, residence, 50c, desk, \$1.00 Present rates for extension phones, wall, business, \$1.00; desk, \$1.25.

Present rates for rural phones switched only 25 cents.

Proposed rates for residence phones, wall, \$2.00 per month single line in city limits.

Proposed rates for residence phones, desk, \$2.50 per month, single line in city limits.

Proposed rates for business phones, wall, \$3.00 per month single line in city limits.

Proposed rates for business phones, desk, \$3.25 per month single line in city limits.

Proposed rates for residence two on line \$1.50 per month.

Proposed rates for extension residence wall phones 50c, desk \$1.00.

Proposed rates extension business wall phones, \$1.; desk \$1.25.

Proposed rates rural phones switched only 50c per month.

We have asked that the above proposed schedule of rates be allowed to go into effect August 1. Each consumer is therefore notified if there is any objection to the proposed, that such objection should be made in writing to the Corporation Commission at Little Rock, Arkansas at least ten days prior to the effective date of the proposed schedule.
