The Brewers and Engineers Refuse to Go Out."

District Assembly 49 Orders a General Return to Work.

NEW YORK, Feb. 11.-The eccentric engineers refused point blank to obey the order of District Assembly No. 49 to strike. At the headquarters of the assembly this morning the reports of delegates who had been sent out to see what steps the engineers were taking in the matter of obeying the order, reported that the men refused to quit work. The reports from the different breweries were equally discouraging, and it was generally admitted that the last effort of 49 had proved a failure. An official of authority stated that the engineers and brewers had been called out at too late a period, and he frankly admitted that the strike was a failure. Considerable dissatisfaction is felt with the executive of 49 because of the manner in which the strike had been conducted. A prominent mem-ber of the Freight Handlers' union said today that there were two or three men holding rank in 49 who wanted to run the whole business for their own ends. A number of longshoremen stood around the headquarters, and several of them openly declared that they would go to work unless more financial aid from their union was granted them. A similar opinion was expressed by other members, and it would not be surprising if there was a general break in the ranks of the strikers at any moment.

The news of the refusal of the engineers and brewers to obey the orders of District 49 was received with dismay by the 'longshoremen. The general impression among them is that their case is hopeless. The beach walkers were busy this afternoon trying to influence truckmen in favor of the strikers, but unavailingly.

route greeted each car with yells, and hurled sticks, stones and mud at the win-MAYOR BOWMAN'S ASSASSIN. He is Believed to Have Been Caught .. Alleged Witnesses of the Crime.

St. Louis, Feb. 11.—On the evening of the 20th of November, 1885, John B. Bowman, ex-mayor of East St. Louis and one of the wealthiest and most prominent resiand Thomas Furiong, chief and Pacific railroad sceret service, and other skillful detectives, have worked other skillful detectives, have worked case, almost constantly on the case, no definite clue to the assassin was discovered until the past few days. Some two weeks ago Christian Schmidt and William Banks, two young hoodlums of East St. Louis, were arrested for robbing railroad cars. Yesterday they made a statement that George W. Voice, a member of the East St. Louis police force, was the murderer, and that they saw him shoot Mr. Bowman. To-day Voice was induced to come to St. Louis and was taken to Detective Furlong's office, where he was charged with the deed, and where he underwent a severe examination, which resulted in Frank Bowman, the son of the murdered man, swearing out a warrant against him. He was sent to Belleville, Ill., to-night, in charge of two of Furlong's detectives, and out a warrant lodged in jail. Voice has for several years been known as a pretty tough citizen, and

killed Axman five years ago. He was a bartender for Timothy Halloran, a brother of the chief of police at the time Mr. Bowman was murdered, and was soon after placed on the police force, where he has since served. It has always been believed that Mr. Bowman was killed by hired assassins, and if Voice proves to be the right man his trial will no doubt result in developments of the most startling character.

NEW YORK, Feb. 11.-The suit of John H. Lester against Gen. B. F. Butler for \$100,000 for false imprisonment and damages is on trial in the United States circuit court. The complaint alleges that on Jan. 25 1864, Lester, who was living in Richmond, Va., came across the lines and took the oath of allegiance at Martinsburg, Va. He there made arrangements with Gen. Butler that his wife and child should be brought to him on a flag of truce boat. Lester then went to Washington, and while there, it is claimed, Gen. Butler became possessed of the idea that he had \$160,000 in his possession, and that he had violated his oath and was helping the enemy. When accused of this Lester, who had returned to Butler's headquarters, denied it, but was thrown into prison. Lester and the child were searched and in her possession, it is alleged, was found \$12,000 which Gen. Butler took and gave her a receipt for \$6,000. which amount was afterward returned. Gen. Butler never let Lester know that his wife and family had arrived at Fortress Monroe, and it was only by chance that Mrs. Lester learned that her husband had been court-martialed and sentenced to ten years imprisonment at hard labor, with a chair about his leg. Lester was released after he had seeved one year, one month and seventeen days. The case will proceed Monday.

The police protection with which he is surrounded is very objectionable to him, and he suffers it only at the special request of the empress. A ruler who knows that by vttering the one word 'constitution' he can save himself, and who yet leaves that word unspoken because it is incompatible with his dignity and with the welfare of his people, is certainly not a nervous coward. 
