More Examples of Exorbitant Charges by Election Judges

-- The District Court. Through all the newspaper talk concerning the legislation which the Hennepin delegation to the legislature is reputed to be planning, there have been frequent allusions to a scheme to abolish the municipal court. Now no man can say truthfully that the Democratic members-elect have decided to attempt the abolishment of the municipal court. But, suppose they have arrived at some such decision? Would it be such a bad thing for the city if the muncipal court were to cease to exist? What is the municipal court? An anomaly. It is a court and yet it is no court. In criminal business ats jurisdiction extends to misdemeanors alone and to the preliminary demeanors alone and to the preliminary hearings accorded persons accused of crime. In civil matters it is above the justice's court and below the district, possessing some of the characteristics and powers of both, and yet unlike either. An appeal from the municipal court goes directly to the supreme court. In this respect it seems to stand on a level with the district court, but it doesn't. Suppose it were intended to do away with the municipal court. Could not some tribunal be established to do the work of the municipal court, and at the same time obviate the clumsness which obtains now! How would it do to establish a criminal court take care of all tains now! How would it do to estab-lish a criminal court to take care of all the criminal business of the city? Under the present system, if a man commits a crime, or is accused of a crime, he has a hearing in the municicrime, he has a hearing in the municipal court. Then he goes to the county jail, where he is held, maybe a week, maybe a month, maybe sixty days. There he is an expense to the company, and, more than that, he is done an injustice. In many cases men charged with criminal offenses are innocent. Why should they be locked up for weeks and months. Would it not be a good thing to have a criminal court where men arrested for criminal offenses could be given a speedy trial?

fenses could be given a speedy trial? Besides being an advantage from the standpoint of justice and economy, it would relieve the already overbur-dened district court. Should such a court be established, the civil business which now goes to the municipal court could be handled by the justices of the peace and the district court. Where is the necessity for a municipal court and a justice court, with almost equal jurisdiction? As for the misdemeanors, which now constitute almost all of the which now constitute almost all of the criminal business of the municipal court, they could be taken care of either in the justice's court, or in the police court. Nearly all of them are small court. Nearly all of them are small matters, like drunkenness, or disorderly conduct. Whatever is done, it certainly looks as if the municipal court could be done away with and the city be no loser

The commissioners of these various boards should be appointed. The same is true of the judiciary. The Republicans have themselves to biame for this matter, though, as they refused to accept the proposition of the Democrats."

Out of all the talk concerning possible or probable legislation has come one acor probable legislation has come one acknowledgment. It comes from S. A. Stockwell, of the Thirty-third district, who has already matured one plan for proposed legislation. It relates to the street railway company. It does not mean interference with that company's charter, but it contemplates making that corporation pay something to the city for the valuable privileges it enjoys. Mr. Stockwell says that the street railway company has about \$4,000,000 or Mr. Stockwell says that the street railway company has about \$4,000,000 or more in stock, which represents nothing more than the privilege to use the streets. He proposes that this privilege should be paid for to the people instead of giving it to the stockholders as a bonus. He says that in other cities the use of the streets is paid for, and he quotes figures from New York and New Orleans in subtantiation of his statements. He thinks Minneapolis has missed one of the most fruitful sources of revenue for many years, and he wants to make up for it as soon as possible. Although the scheme soon as possible. Although the scheme is not fully matured, it is now proposed to tax the street railway a given percentage upon its gross receipts. This will require that the people know exactly what the receipts are, and it will show to a degree, at least, where the money goes.

GATES ARE DEMANDED.

The H. & D. Must Protect the Public - Hennepin Boulevard Car

The council committee on railroads met yesterday and wrestled with the Hastings & Dakota tracks problem. The committee seems unable to get anything out of the Chicago, Milwaukee & thing out of the Chicago, Milwaukee & St. Paul Railway company, not even a proposition, and under these circumstances the committee decided to take some positive action. The council will be asked to pass a resolution directing the city attorney to notify the Milwaukee company that within sixty days gates must be crected on all crossings now onen to the public, from First avenow open to the public, from First avenue to Hennepin avenue, inclusive. In the event of the company failing to put up the gates within the required time, the chief of police will be ordered to see that the ordinance prohibiting the running of trains within the city limits at a speed above six miles an limits at a speed above six miles an hour be enforced. The committee will also recommend that the ordinance allowing the construction of the Minne-apolis Western railroad's line be passed. This part of the contemplated belt line around the mills will extend from Eighth avenue south up to Fifth avenue south on Second street: thence across to First street, and up to a point above

The Hennepin boulevard electric line was also considered by the committee, and the council will be asked to order it built from the junction of Lyndale and Hennepin avenues, out Hennepin to Thirty-fourth street, on Thirty-fourth to Calbony station, and thence to Hayriet Calhoun station, and thence to Harriet over the motor line. A line will also be ordered on Lyndale, from Twenty-seventh street to Thirty-first street, on Thirty-first to Bryant avenue, and out Bryant to Fortieth street.

DEBT-PAYING IN CHINA. Curious Results of a Practice of

the Country. A writer in the North China Herald, of Shangnai, lately takes for his theme the peculiar Chinese practice of settling debts just before New Year's day, which has often been praised by West-ern observers, but which he does not applaud so much. The custom has, he says, its roots in three causes: First, that everybody owes something; secondly, that a great necessity exists for short settlements: and thirdly, that no one will pay a debt until he is forced to the something of the settlements. do so. Tyrannical custom compels most persons to live beyond their means. Marriages and funerals are the ruin of the people. The farming classes are in perpetual difficulties, while the small traders work on such a narrow margin that frequent "accommodation" is es-

sential.
On the other hand, the balances in the hands of creditors are so small that no one can afford to leave his money out of call for more than a few months. on the other hand, the balances in the hands of creditors are so small that no one can afford to leave his money out of call for more than a few months. Finally, the universal habit is to avoid discharging liabilities if possible. So at New Year's time there is a perpetual sequence of flight and pursuit. Creditors hunting delinquent debtors are themelves hunted by hungry creditors of their own. The nation, in short, revolves in a vicious circle, and its only period of brief pause is New Year's day. The double anxiety of a Chinese in the twelfth moon is to find some one else and not to be found himself. Any particular creditor hunting any particular debtor will find that he is himself anticipated by a swarm of other creditors hunting the same game. It is greatly to the interest of all parties that no claim for debt should get into the courts of law, for this would mean that not only the amount in dispute, but all the rest of the property of both parties, would be in danger of being wasted.

For these reasons it is the role of the debtor to represent that he is harrassed by importunate creditors to such an extent that he knews not which way to turn. In ninety-nine cases out of one hundred the creditor is compelled to "call again;" then the debtor sets his wit to work to invent new occasions to beg for a writ nolle prosequi. If the creditor were to relax his hold and cease his claims, that would be the end of them for an indefinite period, perhaps forever, and this he knows as well as any one. Therefore, once having taken hold, he keeps his grip, like the jaw of a bulldog, till he gets his pound of flesh. Eternal vigilance is the price at which this is to be won; eternal vigilance is what the Chinese creditor has a large supply of.

prime object of many debtors during the trying period which follows the winter solstice.
