The Council Has a Regular Old-Time Hair-Pulling Match.

The Parkhurst People Are Beaten in the Curb and Gutter Fight.

Peddlers' License Raised Out of Sight--Other Aldermanic Doings.

An Old Man's Suicide--The District Court's Comedy

of Errors.

Last night's council meeting was a hot one. The peddlers' license and the curb and gutter matters were both up. On both of these was a hard fight. Gore flowed and oratory was worsted. Lots of stuff meant for oratory was inflicted upon patient listeners and the strong prevailed in last case.

The curb and gutter question came up at 9:35. There were two reports on this matter, indicating a fight. The fight began in the committee meeting in the afternoon. Seven bids were received in answer to the second advertisement. They were as follows, the price stated for curl and gutter being the price ser for curb and gutter being the price per

But it is doubtful if the committee on paving would award the contract to Parkhurst were he to offer to do it for nothing. It was not a Parkhurst committee. The old fight, prolonged through so many weeks, had begun again. The anti-Parkhurst members of the committee couldn't consistently recommend the award of contracts for artificial stone to Nyvall & Westland, the next lowest bidders. They might be accused of bad faith in advertising for proposals and then refusing to award the contract to the lowest bidder. It would look to the lowest bidder. It would look queer. So they decided to throw out all the bids on artificial stone. The at the Pence yesterday. presented to the council was as outlined above. The minority report, signed by Loye, was different. It recited that the property on nearly all the streets on which curb or curb and gutter has been, ordered, desire artificial stone. It is stated that the award of the contract as recommended by the majority report would cost the city \$14.740 more than is necessary. Then majority report would cost the city \$14,740 more than is necesary. Then the minority report recommends that the contracts be awarded thus: to Ring & Tobin, for 12,800 feet of Kettle river sandstone at eighty-one cents per lineal foot; to the Parkhurst Paving Company for 44,900 feet of artificial stone curb, or all the remainder at texturises. or all the remainder, at forty-nine cents per lineal foot, by far the lowest bid.

Loye made a speech. He recited facts obtained from petitions in support of the statements made in his minority report. He upheld the right of petition, the only manner in which the wishes of the public can be put before the consoli the public can be put before the council.

Kitchli replied. He prefaced his remarks by stating that natural stone can marks by stating that natural stone can be crushed only under a pressure of 19,000 pounds, while a 440-pound pressure will crush artificial stone, as demonstrated by the building inspector's test. Kirchli became personal in referring to Loye's attitude on the question. He quoted Loye as saying he was working in the interest of the taxpayers. Loye replied that he was for the taxpayers, because, by the adoption of his minority report, the taxpayers would be saved \$14,740. Rand waived his voice again. He was not in favor of giving the Park He was not in favor of giving the Parkhurst people anything. He wanted natural stone on all business streets. That was his plaint. No one disagreed with him

with him.
Grimes moved that the whole question be re-committed. The bids were opened only that afternoon. All were very low. He thought more time should be given to the subject. Potter recommended his motion, and told why. The charter provides that no special assessment shall be ordered except by a two-thirds vote of the council. Some assessments for curb and gutter were levied ments for curb and gutter were levied for artificial stone. He believed, and would so rule, were he in the chair, that those artificial stone assessments could those artificial stone assessments could not be overruled, except by a two-thirds vote. Haynes spoke for recommittal, becarse he did not believe that property owners on all the streets in the city wanted natural stone. The desires of the property owners should be considered. He struck the keynote of this protracted fight when he said:

"We know that this is all a matter of business. We know that it is a fight between the natural stone contractors and the artificial stone manufacturers

and the artificial stone manufacturers and their adherents. The public should have a word to say in the matter."

Lovell upheld the motion to re-commit. McGowan made another speech. So did Loye. On a vote the motion to re-commit was lost 14 to 11

either side. "And I want to say," Haynes continued, "that if I come in here as a property owner on a residence street, and asked for artificial stone, which I knew to be right, I would feel that I had been outraged." The minority report was lost, 16 to 7.

The Majority Report Was Adopted by a vote of 16 to 9. Those who voted against the omnibus report were Haynes, Loye, Lovell. Brozie, Flanders, Reeves, Farnsworth, Potter. The resolution lution accompanying the majority re-port, giving all the curbing to Ring & Tobiu was read. Barrows sprung an amendment giving property owners the right to set artificial stone curb where all in one block desired it, the Park-hurst people to get the contract in such That amendment was ruled out cases. That amendment was ruled out of order. No streets were designated. Potter offered an amendment substituting artificial stone for natural stone on four streets. That, too, was lost. Then the omnibus resolution awarding the contrat for all curbing to Ring & Tobin was adouted by the same vote.

During the voting Brazie explained his vote of no, declaring that it was evident that there was a combine in ths city council. "If there's one, there'e two," retorted Parry, "only one combine hasn't votes enough,"

At the close, Gray who was in the chair, expressed a doubt of the legality of passing the resolution other than by a two-thirds vote. This was the point raised by Potter. The city attorney did not sustain him. not sustain him.

LICENSES GO UP.

Peddlers Discriminated Against After a Hard Flght.

The joint committee on licenses and rdinances made the report outlined several days ago, increasing peddlers' license fees from \$75, \$25 and \$10 to \$125, \$75 and \$20. Of course, there was a big \$75 and \$20. Of course, there was a big fight over it. Ald. Durnam, a member of that joint committee, moved to amend the reported ordinance so as to place the license fees where they have been. Of course, Flanders supported the report. So did Rand. The Sixth ward orator became very dramatic. McGowan moved to amend the clause relating to special permits for peddlers. He wanted the mayor to have the power formerly exercised by the police commission. This point is the one Rand refused to notice in the commission. Parry related personal commission. Parry related personal reminiscences of life in a grocery. Ald. Brazie called attention to the excessive tax which the council was asked to put upon peddlers. At \$150 a peddler would be paying taxes upon \$7,500 worth of property. Yerxa pays taxes on the big gest stock in the city, and he is assessed for only \$7,000 worth of stock. Brackett comes next with \$3,600, and Hart next with \$1,700. with \$1,700.

Flanders, who combines grocery busi ness with paternal regard for the city, read a long, carefully prepared, type-written statement that didn't state anything. There was internal evidence in the paper of great, though latent, literary ability. Ald. Flanders refused to divulge the name of the author. Through an oversight, the council failed to order that Flanders' speech be printed in the regular proceedings. Perprinted in the regular proceedings. Parry related some more personal reminiscens. Brazel spoke again, combatting the statement that peddlers sell lecayed fruit. His wife, he says, buys just as good fruit from peddlers as from grocers, and pays not more than half so much for it. McGowan made another long speech upholding his confidence in the committee.

Ald. Haynes took the floor and shat-Ald. Haynes took the floor and shattered the one point upon which the adve & of the increase urged. The one strong argument advanced for raising the license was that peddlers sell decayed, unhealthful goods. Mr. Haynes held that raising the license wouldn't stop the sale of articles dangerous to health. That can be done only through proper sanitary regulations. As for equalizing con-ittions, it is illegal, unjust, to endeavor to regulate commerce by taxation. Where would it end? As by taxation. Where would it end? As for the sale of decayed food, he thought the grocers should say nothing. Nearly everything they sell is adulterated. He would vote against the adoption of the report because the attempt to equalize commercial conditions is subversive of equal rights, and because increasing the beene will not correct the abuses.

Ald. Gray held that the vital points of this license question are: The regula-tion of it to prevent two peddlers from working under one license; the inspecion of their goods by an employe of the thealth department. The previous ques-tion was moved and afterward with-drawn. Flanders spoke for McGowan's arawn. Flanders spoke for McGowan's amendment, offered as a substitute for Durnam's amendment. Of course he did. The carrying of McGowan's substitute would kill Durnam's amendment to leave the license as it is.

The previous question was called for. McGowan's substitute came first. It was lost 13 to 12

was lost, 13 to 12.

was lost, 13 to 12.

Loye here presented a substitute for Durnam's amendment. The substitute placed the wagon license at \$100; push carts, \$25; foot peddlers, \$10. This was an increase of the wagon license alone. Loye's substitute was lost, 21 to 4.

The question recurred on Durnam's amendment to leave the license fees where they are. Barrows explained his vote. He was on the committee, agreed to the compromise report and, therefore to the compromise report and, therefore, was forced to vote no. Durnam's amendment was lost, 15 to 10. That practically settled the vital point of the report and the ordinance. The ordinance was then passed, 16 to 9. The license for peddlers will be hereafter \$25 for wagons. \$75 for nuch carts. \$90 \$125 for wagons, \$75 for push carts, \$20 for push carts. The mayor may veto.

Some ten years ago Mr. Longfellow met with an accident which impaired the mind. met with an accident which impaired his mind. Since that time he has been subject to mental aberration extending over brief periods. It is thought that he was deranged vesterday when he took his own life. None of the family noticed anything wrong with him yesterday morning. He went out to the barn along about 9 o'clock. Nothing was thought of his absence. Mrs. Getchell, his daughter, supposed that he was somewhere about the house. As the dinner hour approached his absence was noticed. One of the children went out to look for him. There in the barn hung the lifeless remains of the boy's hung the lifeless remains of the boy's grandfather. The body was already

Mr. Longfellow came to Minnesota in 1851. Up to 1880 he was engaged in farming near Minneapolis. Up to that date he was regarded as a remarkably healthy and healthy and strong man for his age. In 1889, while bringing a load of hay to Minneapolis he fell from it, striking on his shoulders and the back of his head. He never recovered from this and has been ailing since. He was compelled to been ailing since. He was compelled to give up farming because of it. His son-in-law, J. J. Getchel, attended to the farming interests and the old man lived with him. He was able to be about, and Monday visited his son's commission store and spent an hour or so there. His business and family relations have been pleasant always. ions have been pleasant always.
