New York. Special to the Globe. DENVER, Col., Feb. 16 .- Gov. Boies' failure to mention silver in his speech at the Greystone banquet here a short time ago has been severely criticised in many quarters, and has caused much comment. A dispatch is alleged to have

come from Gov. Boies' home, Des Moines, Io., last night, saying that the governor was not to blame for ignoring it, and that he was requested by a committee from Denver not to touch upon the subject. The item gives as a reason for this re-

quest that Boies, who is a well known silver supporter, wished to gain Eastern patronage by apparently taking a position against silver, while it would be understood by the Western Democrats that he was in reality a strong believer in free coinage. Senator McKinley, of Denver, the committee of one who visited the governor at Des Moines, was seen, and, when asked whether such was the case, positively refused to talk on the subject, but gave the impression that he could throw considerable light on the matter if he desired to.

Harrison Gave It. NEW ORLEANS, Feb. 16 .- Andrew Carnegie, the millionaire iron manufacturer of Pittsburg, arrived in New Orleans yesterday morning, accompanied by his wife and a number of friends. In an interview Mr. Carnegie said: "Relative te the iron industry, I can say that the McKinley bill has been a blessing, not only to manufacturers, but also to the workingmen. President Harrisen will be the nominee of the Republican party in the next campaign, and he will be elected, even if the whole undivided and solid Democratic party stands arrayed against him All party stands arrayed against him.
