# TORN BY TORNADOS

WIDE EXPANSE OF TERRITORY SUFFERED BY A STORM OF GREATEST SEVERITY

IOWA IN THE DIRECT LINE

While Towns Did Not Suffer Greatly. the Farming Community Felt the Force of the Wind-One Life Reported Lost-Sections of Wisconsin, Illinois and Nebraska Also Visited by Storms.

SIOUX CITY, Io., May 31.-Sioux City was in the center of five tornadoes, last night, which did much damage in Iowa. South Dakota and Nebraska. One storm struck near Kingsley, Io., a second near Jefferson, S. D., and three across the Misgouri river in northeastern Nebraska. No lives are reported lost.

A tornado formed about three miles southeast of Kingsley, Io., and moved northwest one mile, where it struck and demolished the large barn and outbuildings of William Adams' farm, west of town. From this place it moved north to the farm owned by W. A. Stevens, where it literally demolished every building on the place. A family by the name of Johnson, who lived at this place, was saved by going into a cave. The tornado entimued its course north to the farm of J. Kelner, where it demolished the buildings. North of the Stevens' farm the storm struck the Balska place, and took everything except the house. No loss of life reported. Some stock was killed.

In South Dakota the damage was all onfined to the farms. No loss of life is telieved to have occurred. Fortunately, the tornado, which swept through a thickly settled country, did not hit many farm houses, although it passed very close to two score of them, their escape from destruction seeming almost miracu leus. Passing to the north of town the cloud struck the farm house of Joseph Yertes, blowing one-half of the house into fragments and scattering his furniture in all directions. The residence of E. Berchard was blown into thousands of pieces. Berchard saw the storm coming and went into the cellar, with his wife and child, All escaped Injury except Mr. Berchard, who was bruised about the

There were three twisters in northeastern Nebraska last night. The storm that passed between Ponca and Newcastle followed along the ground for several miles before it broke up. John Wilbur lost everything but his house. Charles Mur-fin's house and barn were wrecked. Samuel Green's barn was destroyed and Jake Dennis lost both his house and barn. James Cores' house was totally de-molished. Corge Welbeck's barn was blown away

# MUST FIGHT TRUSTS

MISSION OF THE DEMOCRATIC PARTY IN 1900 IS POINTED OUT BY LEADERS

MONEY NOT THE ONLY ISSUE

Speakers Dwell Upon the Growth of Trusts, and Point Out the Dangers That Confront the Great Majority of the People-Speech of ex-Gov. Altgeld Before the Bimetallic Convention. LOUISVILLE, Ky., May 31.-The Ohio

Valley League of Bimetlic clubs, comprisrg the states of Ohio, Indiana, Ililnois and Kentucky is holding its third annual onvention in this city.

MacCauley's theater, the scene of the gathering, was profusely decorated when the convention was called to order at 2:30 o'clock this afternoon. 'The likeness of William J. Bryan was suspended from the fly, immediately over the speaker's stand, while the picture of Thomas Jefferson and Andrew Jackson hung from the two upper boxes.

Chairman Semonin, of the local committee. He introduced Mayor Weaver, of Louisville, who extended a hearty welcome to the visiting delegates.

Judge J. P. Tarvin, of Covington, Ky., resident of the Bimetallic League, was introduced and spoke at considerable length. His remarks were at the time received with the greatest enthusiasm, any reference to a redfirmation of the Chicago platform or an indorsement of William Jennings Bryan as the presiden-tial nominee being a signal for vocifer-ous applause. Ex-Senator J. C. S. Bickburn was to

have spoken this afternoon, but he was detained at home on account of the serious illness of his wife.

Following Judge Tarvin, Congressman James M. Robertson, of Indiana, made an impromptu speech. In reference to the coming campaign of 1900 the speaker said that it lay with the Democratic party to name the victor and that they would make a great mistake if they did not select Bryan.

NIGHT SESSION. The delegates were late in reassembling

for the evening session, and it was after 8 o'clock before the convention got down to business. President Tarvin introduced the Hon. Flavius J Van Voorhis, of Indianapolis, whom, he said, had given forty years of his life in defending the principles as enunciated by the Republican party.

The Indiana statesman was heartily heered when he arose to address the convention. The speaker at once entered into a discussion of the financial ques-tion, saying it was the problem of prog-ress and of liberty. He characterized trusts as a social greed which must eventually result in the downfall of a nation. In conclusion he said that the great trusts of the country was the out-growth of an organization of shameless men who are the greatest enemies of

Ex-Gov. John P. Altgeld, of Illinois. was presented. The greatest enthusiasm prevailed when the Illinois statesman arose to address the convention, the del egates rising to their feet, waying hats and cheering lustily. While Gov. Altgeld was in the midst of

his discourse Mr. Bryan, who had arrived in the city earlier in the evening, reached the theater. He was admitted to the stage by a rear entrance, and took a seat behind the flies, where he awaited the conclusion of Mr. Altgeld's speech. After the speeches had been concluded Mr. Bryan and several of the distinguished visitors repaired to the Galt house, where a banquet of the Young Men's Democratic club of Louisville to To attend this and to respond to the toast. The Democratic Party, Mr. Bryan had made a special trip to Louisville earlier than he had expected.

But the money question is not the only great question that confronts us. Calamities go in groups, and the gold standard has brought with it a brood of evils, each of which threatens the life of the republic.

"There is the great question of government by injunction, a system under which a federal judge, elevated to office by corporation influences, strikes down the right of free speech, and with a contemptuous wave of the hand, brushes aside the right of trial by jury, that bulwark of English liberty, at the mere request of a corporate agent.

"The temptations offered by corrupt capital being too great for the ordinary man to withstand, it is evident that as long as these temptations are offered they will be effective. By the establishment of the 'initiative and referendum,' the fruits of bribery could be taken away, and thus the inducement to bribe would be destroyed.

"This is an age of concentration, of the formation of great corporations, of great trusts and of great monopolies. It is found that by consolidation the cost of production can be cheapened, and if the public got the benefit of this, it might be a blessing; it would shorten the hours of labor and advance civilization, but instead of that the benefit of this, it might be a blessing; it would shorten the hours of labor and advance civilization, but instead of that the benefit of it, under the Republican administration, goes to a few private individuals, who, by making themselves complete master of the market, and having absolute control of the output of articles of necessity to the people, are able to arbitrarily fix wages on the other hand. In consequence of this fact these monopolies are not only a curse to the country, but are threatening to overthrow our institutions, for they furnish the corruption funds that are destroying us.

state in the Union has legislated against
them. The federal government has legislated against them, yet in spite of this

found to be absolutely futtle, because fede
eral judges uniformly declared it to be
unconstitutional. Federal legislation has
likewise been found to be futile. The
trusts are masters of the situation. It is
evident that to simply go on denouncing
trusts is an insult to the intelligence of
the American people. It is the cheapest




