On the other hand, Chile has wished to have the discussion of arbitration limited to future questions. 
UNION VERDE STRIKE ENDED.

HELP FOR REBELS

EIGHT HUNDRED VENEZUELAN START TO JOIN FORCES OF URIBE-URIBE

STRICT CENSORSHIP AT COLON

Revolutionary Agent in New York Reports Defeat of Force of Colombian Government Troops.

SILVA SAYS THE OPPOSITE

WILLEMSTAD, Curacao, Aug. 22.—Venezuelan steamers have transported men from Maracaibo and Coro, under command of Gen. Davila, who defeated Colombia near Rio Hacha, and to support them have also sent ammunition to that point.

Gen. Juan Pineda, leader of a revolutionary movement that was about ready to start, was captured near Magdalena, the state of Carabobo, while on his way to Caracas, he was immediately taken to liberty by order of President Castro.

CENSORSHIP AT COLON

COLON, Colombia, Aug. 22.—The Colombian government is now enforcing a strict censorship.

CLAIM LIBERAL VICTORY

NEW YORK, Aug. 22.—Dr. A. J. Rossetto, diplomatic agent of the Liberal party, now attempting to take possession of the government in Colombia, received a dispatch from the Liberal agent at Quito regarding the recently reported battle between the government or clerical forces at Pasto.

This dispatch was as follows: "Quito, Aug. 22.—The battle near Pasto closed on Saturday, August 21, and the Liberal general, Legio Perez and A. Rosas, won a great triumph over the Clerical forces."

Through his secretary, Dr. Rossetto explained that Pasto, where the battle was reported to have been fought, was in the extreme southern part of Colombia, 2,000 miles from where Gen. Uribe was operating, and that it indicated a successful execution of the plans of campaign mapped out by Gen. Uribe-Urbe and forwarded to the commanding officers of the other Liberal forces. The general left New York early in the summer.

THE OTHER SIDE

WASHINGTON, Aug. 22.—The Colombian minister, Dr. Martinez Silva, today received an official letter from the minister of Colombia at Quito, which reports an engagement near Pasto, in which a force of Colombian revolutionists were defeated, and arms, ammunition and prisoners taken. The letter also discloses the satisfactory condition of affairs between Ecuador, Colombia, and disposes of reports that an armed invasion by Ecuadorian troops was to be attempted.

The minister at Quito does not refer to any trouble with the government of Ecuador. He states that almost all the revolutionary chiefs who had fled from Colombia and taken refuge in Ecuador had gone back to Colombia, and he considers this a confirmation of the report that a force from Ecuador was about to invade Colombia and fight a battle near Pasto. Concerning the engagement near Tomaco, the letter states that Gen. Palastus, commandant in the city of Barbaquis, which had been recovered by the government, was in command of the government forces.

STATEMENT BY SILVA

The Colombian minister today discussed the dispatches received by the Colombian press from the government of Venezuela, through his secretary, from President Alfaro, of Ecuador. Dr. Silva spoke without criticism, and confined his remarks to pointing out certain essential points which these messages from the two presidents made clear.

"Coming from such high quarters," said Dr. Silva, "it cannot be doubted that these messages afford excellent means for the present situation of affairs from the standpoint of the governments. The chief point to be noticed is that they do not treat war as existing. The message from President Alfaro expressly states that war between Colombia and Venezuela is improbable, and he adds that such conflicts as have occurred, growing out of the union between the Conservatives in both republics, are of a transitory character. It is well to have the view of so high an authority on the improbability of war, and on the transitory character of the party disturbances which have occurred. This dispatch from Quito is dated Aug. 21, it seems to dispose of the reports of several days ago, saying that an Ecuadorian army was about to invade Colombia and fight a battle near Pasto."

"Evidently the president of Ecuador knows nothing of the imminence of such a conflict."

"The message from Gen. Castro's secretary also indicates clearly that no war exists. It states that the Conservatives of Colombia have resolved to assist in a revolutionary movement against Venezuela, and her government. From this it will be observed that the basis of the affair is a revolutionary movement against Venezuela, and of course such a movement is an internal affair of Venezuela, with which Colombia has no concern. Altogether, the messages seem to be reassuring as to the fact that no actual war in the sense accepted by international authorities, exists or is probable."

"I am perfectly sure that in the revolution in Venezuela there is not one Colombian. I also am well informed that the Colombian authorities on the frontier have made the utmost efforts to prevent Colombian territory from being made the base for revolutionary movements into Venezuela."

ATTEMPT TO BRIBE JURY

CHARGED AGAINST DENVER OFFICIALS AND NEWSPAPER MEN.

DENVER, Col., Aug. 22.—Judge Mullins today denied the petition for a change of venue in the case of Attorney W. W. Anderson, charged with attempt to bribe a jury at the recent trial of Anderson, was filed today by the district attorney, as requested by the accused persons. An information of the same purport was also filed against Fire Warden Sadler, who has left the city.

NEW YORK, Aug. 22.—Financial men named in connection with the formation of a world-wide copper combination today denied all knowledge of such a combination. They said that it would be impossible to harmonize and organize all the conflicting interests in copper, and that nobody was trying to do so. There were reports of a large combination in copper, but no definite information as to the companies that are to be used could be obtained.

BOSTON, Aug. 22.—The officials of the Calumet and Hecla company here declined to make a statement today regarding the reported formation of a huge copper combine.
