The man who says is it-hot enough for you may be killed any time during ing the months of June, July and August.

High-speed automobile fiends may be slaughtered at any time during the year; no limit as to number killed in one day.

Man whose thermometer is always 3 degrees above any other in the summer may be shot during dog days without license.

Fools who rock boats may be killed any time during the summer months. No license required, as there is a bounty on all scalps offered.

Umpires giving the home team the hooks may be shot, clubbed or hunted with dogs from April 14 to October 8.
