The first Christian churches often were in Jewish communities Sometimes they linked the Jewish Passover to the Resurrection One of the early church discussions centered around the need to separate Easter from the Passover A remnant of this old discussion is the use of the term "Paschai" in connection with the Easter season. "Paschai" derives from a term which meant "pass over." Pilgrimages to holy places were an important part of early





Easter celebrations. Some authorities think the need for moonlight to aid the travels of the pflgrims had an important part in setting the date of Easter as the first Sunday after the full moon following the vernal equinox.

One of the early attempts to unify Easter practices was made at the Council of Nicaea in 325. It brought together most of the bishops in the time of Constantine to thresh out perplexing church problems. Constantine himself attended
