## LEVER FOOD ACT TO INCLUDE CLOTHING

**Amendment of Food Control Bill Adopted by House Without Much Opposition, \$5,000 Fine or Two Years for Profiteering.**

Washington, Aug. 23.—Without amendment and with practically no opposition, the House late today voted to amend the Lever Food Control Act to extend its provisions to include clothing, containers of food, feed or fertilizers, fuel oil and implements used in production of necessities, and to penalize profiteers by a \$5,000 fine or two years' imprisonment.

Proposals to make the act apply to profiteering in house and room rents, adopted by the House in committee of the whole, were stricken out in the final vote.

Efforts were made by both Republicans and Democrats to have the amendment's provisions cover necessities other than those included in the amendment as reported by the agriculture committee. Inclusive of kerosene and gasoline was proposed by Representative Strong, Republican, Kansas, who said the price of these products had increased 300 per cent in the last two years, but his amendment was rejected by a close vote while that of Representative Newton, Republican, Minnesota, to include raw cotton was eliminated on a point of order by Representative Blanton, Democrat, Texas.

Attempts to bring farmers and farm organizations within the jurisdiction of the amendment also were blocked.

Recommendations of Attorney General Palmer to include retailers doing a business of less than \$100,000 under the profiteering section so that the department of justice might "go after the little ones" were included in the message as passed.

Five hours of general debate preceded passage of the measure the first legislative step in carrying out the recommendations of President Wilson in his recent address to congress on the high cost of living. The Hutchinson cold storage bill, modeled on the New Jersey act recommended to congress by the President as worthy of patterning after, will be reported to the House next week.

Debate today consisted largely in attacks and defense of the administration, Republicans asserting that the Democrats "with masterly inactivity" had avoided any discussion or remedies for the high cost of living and Democratic members charging that Republicans had been busy playing politics and were not unmindful of coming elections.

Representative Rodenburg, Republican, said that "the President's mind for the last nine months has been completely absorbed by the idea of the league of nations. If there was a famine in China, a flood in the Mississippi valley, an earthquake in Porto Rico, a volcanic eruption in Central America, or an epidemic of spinal meningitis in New York city, the President by a process of reasoning that satisfies himself at least, has convinced himself that the sole contrib-

ing cause was the failure of the league of nations."

Representative Heflin, Democrat, Alabama, charged that Republican opposition to the league of nations had become so pronounced that the chaplain of the House "was not permitted to pray for acceptance of the league of nations." He said the chaplain had offered such a prayer one morning "and since then his lips have been sealed by a high member of the Republican party."

Indication of the close interest with which President Wilson is following every move in the fight on high prices was given today in a lengthy conference which he held with Attorney General Palmer and Director General Hines. The conference was arranged by Mr. Palmer, who declined to discuss what had been under consideration.

Mr. Palmer also was in conference today with the senate agriculture subcommittee considering amendments to the food control act. The committee wanted to have the amendments define "reasonable prices and just profits," but no agreement was reached. It was considered likely that this phase of the congressional share in curbing profiteers was put before President Wilson by the attorney general.

Mr. Palmer today telegraphed Governor Smith, of New York, that Special Assistant United States District Attorney Henry A. Gullar would be assigned to investigate the New York milk situation.

## TRAIN HELD UP BY FOUR BANDITS

**Railroad and Postoffice Detectives Searching. All Clues Followed. Woman may have been implicated in Robbery.**

Nashville, Aug. 21.—With railroad and postoffice detectives scouring middle Tennessee and following every indication of a clue late this afternoon, the four bandits who held up and robbed the Louisville and Nashville passenger train No. 7, ten miles south of Columbia, last night, were still at large. One clue was based on the report that a woman and two men were seen driving in an automobile near the scene of the robbery late last night coincided with the mysterious appearance here two days ago of a woman who claimed to be from a Western State and had a ticket for Glendale, the station near which the robbery occurred.

A slim, delicate looking man of about 25 years with a broken nose is also being sought by the officials, Engineer Wray having told government officials this was the only man who took off his mask. Other clues are being followed.

Although no official estimate of the amount of booty taken by the robbers has been given out, it was rumored here today that the bandits got \$60,000 in cash from the mail car.

According to W. P. Mulvihill, the fireman, two of the bandits boarded the train at Columbia, riding the "blind baggage." When in a wooded section the bandits climbed over the tender and pointing their guns at the engineer and fireman shouted "The train is held up."

The engineer says they were then ordered to run the train until they came to white light. The light appeared just south of Glendale and was a searchlight held by one of the bandits.

While two bandits stayed with Wray, a third compelled Mulvihill to go back with him and cut off the engine, express car, baggage car and mail car. On their way they met S. H. Allen, conductor of the train on his way to the engine to investigate the stopping of the train. After the train was cut, the robber ordered the fireman and conductor to get into the coaches which they did.

The three bandits forced the engineer to drive the engine with the baggage, express and mail attached to it to a point about half a mile beyond where the passenger coaches were detached and there stop.

After rifling the mails, the bandits cut the engine loose, threw the throttle wide open and left the locomotive to spend its power anywhere south of Glendale. It stopped near Wales Station, eight miles north of Pulaski.

Before cutting the engine loose bandit No. 4 made his appearance. According to Wray he was hiding in the bushes along the track.

The clerks and Wray were then ordered to "beat it" down the track with a trail of threats following. The bandits then escaped in an automobile which is believed to have been brought there by bandit No. 1.

Passengers on the train were not disturbed. Many who were in the day coaches knew the train had stopped but not that it was being robbed. Those in the sleepers knew nothing until daybreak.

A. W. Brant, assistant superintendent of the road, stated Thursday he was informed an automobile answering the description of the one used by the bandits, was seen near Franklin

and was headed for Nashville.

Chief Deputy Sheriff Moore stationed men all through the outskirts in hopes of capturing the men.

Express company and railroad officials are of the opinion the men are old heads at the game. They draw their conclusions from the easy way in which the bandits worked and the way the robbery was planned. Brant complimented the crew on the "cool work while under fire." Conductor Allen is one of the oldest conductors on the Louisville & Nashville. He lives in Nashville.
