This, called forth an explanatory speech from Mr. P. H. Nelson on the part of the railroad company. He said that it seemed hard to be understood that the Three C's Company did not want the bonds, but wanted them deposited subject to the order of the commississioner of this county and to be delivered when the contract was complied with, so that better loans could be effected by using these bonds as collateral. The railroad company had already spent in this county \$100,000 before a dollar was received from the county, and it was right that they should ask for a proof of good faith on the part of the county, of which good faith they would be satisfied if the bonds were deposited in the hands of a third party subject to the county's order. He showed that by this plan the rail road company could then be put on this means the county would realize more on the bonds subscribed. He repeated that the bonds were not asked for, but it was requested that they be put in the Boston Safe and Deposit Company's hands, subject to the order ty, and to be delivered to the railroad company when the contract was complied with, and not before. He further showed the absurdity of our insisting on the road being built to the Samter line, as, if the road was graded to the Sumter line, the company could not be forced to go tarther; and if they stopped there, even if trains were occasionally run to the county line, this would be of no benefit to Camden in any way.

After some discussion and explanation the resolution was adopted by a vote of 13 to 7, only twenty persons voting. It was discovered after the meeting that a great many would agree to the depositing of the bonds as already explained, but they endorsed the action of the commissioners, as they were carrying out the letter of the contract. The people of Camden are not opposed to this road, but they insist that the contract which requires portions of the road to be finished before the instalments of bonds are paid should be carried out. There really seems to be no great many ways.

A RIGHT ROYAL RIOT.

LONDON, Sept. 19 .- Neither Gent nor Hutchins, who were extensively advertised to run a 120 yards foot race at Lullie Bridge to-day for the champion ship of the world and £200, appeared on the track at all. Thousands of spectators had assembled and paid to wituess the announced contest. When the crowd were made aware of the situation they were disgusted and soon took revenge in a riot. They attacked fences, railings and buildings on the grounds and burned several of the latter to the ground, partly demolished two grand. stands, a dancing pavilion and a large assembly hall and set fire to the debris which they collected, forming six large bonfires. They then set fire to the wooden railings along the railway and nearly set fire to Brompton station. They next looted the liquor saloons in the vicinity and bombarded the windows and the policemen and firemenn with full and empty bottles. The firemen played the hose upon the rioters, but in vain. After holding possession for three hours the mob was dispersed, when the police strongly reinforced, arrested a number of rioters. A railroad inspector, after a struggie with the mob, dropped dead from the effects of the excitement. The
