#### SUNDAY NEWSPAPER.

The Subject Discussed by the Presbyterian Union.

Majority in Its Favor-It Gives More Moral and Intellectual Nutriment Than Pulpit Platitudes.

The Presbyterian Ministerial Union held its regular meeting yesterday morning in the Howard-street Presbyterian Church, Mission street. There was a small attendance, but the meeting was a most interesting one. The president, Rev. E. J. Scott,

After devotional exercises and a discussion as to the subject for the meeting two weeks hence, J. B. Roberts, an elder, was requested to read his paper on "The Sun-

Mr. Roberts said he had not prepared a paper, and would content himself with reading from a publication certain decisions bearing upon the subject. The first decision was that of a Judge in Atlanta, Ga., to the effect that George P. Rowell & Co. of New York had been defeated in their attempt to collect a large bill for advertising in a Sunday paper, which, it was claimed, estab-lished the principle that the Sunday paper meant Sunday labor. Sunday labor, accord-ing to the law, was unlawful. The second was a decision of a New York Judge against the legality of advertising on the Sabbath. He also read an article from the Argonaut against the lowering of the standard of

inday newspapers. Rev. James Woodworth, secretary, said the Argonaut and Mr. Roberts seemed to demand a higher standard, and simply de-plored the deterioration of the Sunday news-paper. They should not take any such ground, but go against it. Three things should be considered. (1) the Sunday newspaper as it is; (2) whether there should be a Sunday newspaper at all; (3) the reading of what we found in it. He would read his Bible on Sunday, but he would object to a publishing-house publishing Bibles on Sunday. He did not believe they should go to work to labor for the improvement of the work to labor for the improvement of the Sunday newspaper, but if anything could be done for its abolition he would be glad

CHAPLAIN BLAKE'S IDEAS. Chaplain Blake said his first argument was that no Sunday work was done for a Sunday pewspaper, whereas all the work for the Monday newspaper was done on Sunday. In 1850 in Sau Francisco, when there was no Sunday newspaper, no day in the week could be compared to Sunday for gambling and generally breaking the ten commandments. He went to the keepers of the gambling-bouses and remonstrated with them and they said: "You give us something to read on Sunday and we will stop gambling." Sunday newspapers, and thought it necessary for any man to do so to keep step with the movements of the age. There was a great deal of good in the Sunday newspapaper, and in it he had found the ablest articles, morally and intellectually, he had ever read. But they might just as well argue that it was necessary even to read infidel litera-ture, for they should all become acquainted with the ways of the devil.

As to the morality of the thing he would say that people don't spend their time exclusively in spiritual reading. There was no more harm in reading the Sunday newspaper than riding in a cable-car. lated by reading the Sunday newspaper any more than by reading a book on astronomy, travels or a story book. Rev. Dr. Matthews-Why not read religious papers on Sunday?

Rev. Dr. Faris said that the cry of men getting more nutriment, morally and intel-lectually, from Sunday newspapers than from all the platitudes from the pulpit was all humbug and a lie. No doubt there was too much thin preaching, but no one could place even the thinnest preaching on the same level with a Sunday newspaper. He had not yet got over the teachings of his youth that the Sabbath was reserved only for works of necessity and mercy. ### BRUGGY IN COURT.

The Sonoma Condemned Murderer's Last Chance.

Under Sentence to Hang on Saturday-Another Reprieve Probable-Has the New Execution Law Repealed the Old One?

George W. H. Bruggy, who is condemned

to die on the gallows next Saturday, was brought from Santa Rosa into the United States Circuit Court yesterday afternoon on a writ of habeas corpus. The proceeding was instituted by his lawyer, Carroll Cook, as a last desperate resort to save his client's neck. Bruggy murdered a young farmer named Dietrick Louinson at West Windsor, Sonoma County, on February 17, 1890. He was found guilty of murder of the first degree, was sentenced to death, escaped from jail last May, was recaptured 12 days later, and reprieved until July 30. His case has twice been appealed to the State Supreme Court, and in each instance decided adversely to him. Governor Markham having announced his purpose not to further interfere with the course of the law, a final effort is now being made by his counsel to rescue Bruggy from the gallows by showing in the United States court that California has repealed the law which allows Sheriffs to put felons to death. The boint raised is one of great importance as affecting the fate of other murderers throughout the State who are also under sentence of death. sentence of death.

BRUGGY IN COURT. BRUGGY IN COURT.

Bruggy yesterday sat in the courtroom attired in a new suit of black cloth. He wore it for the first time. The suit had been purchased by the Sheriff of Sonoma County and was intended to be worn once only. The Sonoma County Board of Supervisors had authorized the expenditure. The clothes were to give Bruggy a neat and gentlemanly appearance under the fatal drop. No California Sheriff would so far gentlemanly appearance under the fatal drop. No California Sheriff would so far forget the proprieties of his office as to hang a man in a brown or a gray suit. It would not be exactly good form. Black only is en regle on such occasions, and accordingly the Sonoma County convict was provided with Sonoma County convict was provided with a neat black frock coat and trousers to match and a white straw hat with a very broad band of black ribbon. Bruggy's general somber aspect was relieved slightly

general somber aspect was relieved slightly by a light-colored scarf.

Sheriff J. F. Mulgrew of Sonoma County, who, with his deputy, W. L. Tombs, sat behind their prisoner, informed The Call reporter that Mr. Bruggy was allowed to wear the suit intended for his execution before the event, because he was coming down to the city and desired to make a good appearance in the courtroom. Sheriff Mulgrew also gave many points in regard to the etiquette of dress for judicial executions. He thought a man who was to have the distinction of having his neck broken with all the formalities of law should be dressed in black, and did not think any Sheriff in the State would commit the outrage of hanging a man in gray or brown, or even in his shirt sleeves.

THE WRIT OF HABEAS CORPUS. THE WRIT OF HABEAS CORPUS.

Judge McKenna had issued the writ of habeas corpus, but he was not on the bench when the petitioner was brought in. Judge Hawley resolutely declined to make any order in the matter, though Carroll Cook tried very hard to have him make one ordering Bruggy into the custody of the United States Marshal. Shortly after 3 o'clock Judge McKenna ascended the bench, when the return of the writ was made by Sheriff Mulgrew. It was simply that the prisoner was held by virtue of a death warrant issued by the Superior Court of Sonoma

Attorney-General Hart, who represented the State, said he desired to file the julgment roll as an amendment to the return, but he required time to obtain the same.

THE ATTORNEY-GENERAL OBJECTS. Mr. Hart objected on the ground that the return showed that Bruggy was held by virtue of a death warrant. He had no doubt the court had the power to direct him not to be executed. He had joined with Chief Justice Beatty in the request to the Governor for the reprieve, which would explire on Satarday next, and he would ask expire on Saturday next, and he would ask the Governor for a further reprieve, not only in this case but in all others affected

by the same point.
Mr. Cook urged with great persistence an adjournment of the hearing until Tuesday, August 2, which would be three days after the time fixed for the execution. The Attorney-General also seemed disposed to accommodate Mr. Cook, but with the remark that the case was one that transcended questions of individual convenience Judge McKenna set the case for hearing at 2 o'clock next Thursday. The prisoner was thereupon remanded to the custody of the Sheriff, who took him back to Santa Rosa on the 5 o'clock boat. Rosa on the 5 o'clock boat.
