In States having a considerable business in the sale of cuttings, it was deemed necessary that vineyards from which cuttings were sold should be inspected and certified as nurseries.

6. It was generally agreed with respect to the wooly aphis that gradually increasing pressure should be brought to bear for the reduction of this insect in nurseries, but that no uniform practice could be established because of wide differences in its abundance in different States. The New York practice of requiring the rejection and destruction of trees sufficiently infected to show knots on the roots was commonly approved. It was also thought well to require insecticide treatment, with kerosene emulsion; of nursery trees whitened by this insect. A similar policy of gradually increasing pressure of requirement was also recommended with repsect to those States where it is not now generally and uniormly distributed. It was held at present to be unwise to require the destruction of trees exposed to infection with crown gall, but not visibly so infected. 
