### Ordinance No. 35

Ordinance No. 36

AN ORDINANCE CREATING the office of "Sealer of Weights and Measures.

Be it ordained by the Mayor and Common Council of the Incorporated Town of Winslow, as follows:

Section 1. The Common Council of the Town of Winslow is hereby authorized to appoint one or more competent persons. the same to hold office during the pleasure of the said Common Council, to weigh, measure and inspect all coal, hay or other like commodities usually sold by the ton or fractional part thereof in the said town AN ORDINANCE PROHIBITof Winslow.

The person or persons so appointed, shall, before entering upon such duties of inspector, weigher or measurer, and to the satisfaction of the Common Council, give a good and sufficient bond with not less than two sureties, in the penal sum of One Thousand Dollars and with condition that each ton of hay, coal or like commodity weighed, inspected or measured by him shall con- other commodities of like natsist of two thousand pounds.

Section 4. That the said Sealer of Weights and Measures. shall inspect, weigh or measure all loads of coal, hay and commodities of like nature at said official scales:

That he shall keep a record maintained for such purpose, in which shall appear a statement of all loads so inspected. weighed or measured, submitting the same quarterly to the Common Council:

That the ordinary scale of weights and measures shall be weighing, inspecting or measuring of all loads;

That each load weighed, inspected or measured by him shall be accompanied by his certificate of the number of tous or pounds and it is hereby made his duty to issue such certificate after weighing, inspecting or measuring each load.

Section 5. That the said Sealer of Weights and Measures shall receive for all services rendered in inspecting, weighing or measuring as above, from the venders, the sum of twentytive cents for each ton or fractional part thereof.

Section 6. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

This ordinance shall take effect and be in force from and after its passage.

### Ordinance No. 37

ing the sale of Coal, Hay, And Like Commodities, Except On Condition That The Same Shall First Be inspected, Weighed Or Measured.

Be it ordained by the Mayor and Common Council of the Town of Winslow, as follows, to

Section 1. It shall be unlawful for any person, persons, corporations or individuals to sell, vend, barter or exchange coal, hay or ure, usually sold by the ton or Section 3. The person or fractional parts thereof, to be

Section 2. Any person, persons, corporations or individuals violating any of the provisions of the preceeding section shall be deemed guilty of a misdemeanor and upon conviction shall be fined in asum of not less than, ten nor more than three hundred dollars, or by imprisonment of not less than five nor more than ninety days, or by both such fine and imprisonment.

Section 3. All ordinances and parts of ordinances in conused by the said Sealer in the flict with this ordinance are hereby repealed.
