The Astoria Railroad.

It was reported on the streets yesterday afternoon that a telegram had been received by the Astoria chamber of commerce from Henry Villard, in which that gentleman declines to allow that body access to the reports of the surveys recently made by the engineers between this city and Forest Grove.

Mr. Villard's statement that he would give \$30,000 in bonds to any one contracting to build the road included the proviso that the road must be built in accordance with the plans and specifications of his engineers. Declining to allow "parties of the second part" access to those plans and specifications would argue lack of sincerity on the part of Mr. Villard. If an Astorian were to tell a carpenter "I will give you \$25,000 to build me a house, in accordance with certain plans I have," and immediately refused to let the carpenter see the plans in accordance with which the house must be built, the presumption in the carpenter's mind would be that some one was trifling, and the trifling party was not the carpenter.

From London comes to us authentic information that on the 19th of Sept. the construction bonds of the O. & C., were selling at 96. So that the \$30,000 in bonds which Mr. Villard says he will give anyone contracting to build the railroad from Astoria to Forest Grove (according with his engineers' plans and specifications) are worth about \$28,800, in cash.

In his message to the territorial legislature, Gov. Newell says, the report of the board of pilot commissioners for the Columbia river and bar shows a decided increase in the commerce of that great river. The pilots are uniformly successful in their hazardous occupation and have the confidence of masters and owners. There is no longer any conflict with the Oregon board of pilots, many of whom take branches from the Washington board. The laws of this territory and of the state of Oregon respecting the navigation of the Columbia, especially as relating to the rates and general supervision of the pilot service, should be harmonious, and indeed might well be identical. A conference upon this important matter with Oregon authorities may lead to the adoption of such improved and uniform laws and regulations as would promote the convenience of mariners and insure to the advantage of commerce on both sides of the river. The abolition of the Puget sound system has not been injurious to commerce, which has been increased one hundred fold. If any new measure is enacted it will be well, in view of the conspicuous and safe navigation of the straits and the sound, and the large coast-wise commerce, that it be based upon the optional feature of pilotage.

No newspaper is more eagerly read in THE ASTORIAN office than the N. Y. Sun, as that journal always affords pleasure, and often amusement. Its editorials on the use of correct English are masterpieces of argument, but a due observance of its own rules would save the editor from such glaring mistakes as occurred in his issue of the 19th ult., where he says "he layed down." The idea!

ME. SAMUEL JONES TILDEN of happy memory has told a New York reporter that if every man, woman and child were to sign a petition asking him (S. J. T.) to accept a presidential nomination, he would refuse. This illustrates the positive nature of Mr. Tilden's position.

The Tacoma Ledger says "the books of a leading shipping merchant of Portland, shows that the cost to a ship of 1076 tons loading at Portland, exceeds the necessary cost to a vessel of the same size loading at New Tacoma \$2,028. In other words it costs two dollars a ton more to load wheat at Portland than at Tacoma."

To be entirely candid the Ledger should state the whole truth, and go on to show the facts in the case which are that the cost of a ship of 1076 tons loading at Astoria, is far less than the necessary cost to a vessel of the same size loading at Tacoma, a fact which has been proved on more than one occasion.

The Standard is perturbed over the fact that Ames, the Massachusetts Republican nominee for lieutenant governor of the Bay State, is rich, and may use money to secure his election. This is indeed sad. One of the funniest things in this funny world is the fear that possesses the average Democratic editor that his opponents will use money. The fear usually manifests itself about election time into a personal concern lest the a. D. e. may not get his share of the swag.

It is with regret we notice in an eastern journal as one of the alleged reasons why Indiana Holman should be given the Democratic presidential nomination, a recital of the statement that Holman's grandfather was killed by Kentucky Indians.
