There was considerable discussion over the Australian ballot plank in the platform, but it was finally adopted.

Sixty St. Paul Citizens Inaugurate a "Reform" Movement.

St. Paul, Ming., June 10.-A new political party has been launched in this city under the name of the national association, sixty gentlemen of St. Paul and vicinity filing articles of incorporation with the secretary of state of Minnesota. The leader of the new party is Charles F. Huff, the well known St. Paul contractor. The objects of the party as stated in the articles of incorporation are to 'unite socially and fraternally all respectable citizens for the purpose of bettering their conditions in private or public life by a course of debates upon political subjects, from which will result a more thorough knowledge of what is needed in the way of reform or political economy in the counties, the states and the nation. "It will give us a clearer idea, from the in-

terest shown by the different individual members in these debates, of their fitness as candidates for different positions of trust as public servants, instead of picking them from the roster of a base political party as has been done heretofore, contrary to the feelings of the well meaning citizens of the different communities," said Mr. Huff. The new party is to be on a secret society basis, but will not be exclusive. Its mode of nominating officers is unique. Whenever elec-tion time opproaches, the ward or township associations meet and take a paliot for canward or township officers the person receiv ing the highest vote shall be the nominee. In votes for county officers the board of the ward or township organization shall be certified to the county organization, which is composed of representatives from each of the ward or township organizations. The man who has received the most votes is declared the candidate and all other members of the organization are sworn to vote for him. For state officers the same plan is to be followed. except that the votes from each ward are forwarded to the county organization and then to the state organization, and by that organization the declaration made as to who the candidates of the association are, In an interview Mr. Huff declared that the "supreme association," which is now com-posed of only sixty St. Paul men, would be fore many days have an organization in every county in Minnesota, and he expects that his party will cut quite a swath in politics. This organization will be extended to other states as fast as possible, and by next year the leaders expect to have sufficient year the leaders expect to have suncient strength to warrant the nomination of a can-didate for president of the United States. According to Mr. Huff, forty canvassers are in readiness to start out through Minnesota, and as soon as the printing is completed they will begin their work.

Ohio Prohib State Convention. SPRINGFIELD, O., June 10 .- Over fifteen hundred strangers are in this city, drawn by the prohibitionist party state convention, which met here this afternoon. At 1:30 p. m. the various district delegations made their nominatians for the various committees. The convention will be called to order at 3 o'clock by State Chairman H. A. Thempson. Many of the prohibition notables are on the ground, including Sam Small of Georgia, Sam Dickie chairman of the national prohibition commit tee, Van Bennett of Kansas, and Colonei John Sobrieskh of Nebraska. PRAISES THE BUTCHERY.

Hippolyte's Organ Upholds the Mur-

ders at Hayti's Capital. NEW YORK, June 10 .- L'Ordreau, a Portau-Prince paper entirely devoted to the government of General Hippolyte, publishes in its number of May 30 a rather threatening paragraph in regard to the conduct of the foreign consuls during and since the present bloody occurences in the Haytian capital. It is usual in such cases for the defeated beligerents to find a refuge in the consulates which enjoy in Havtl and in the Spanish-American countries the ancient "right of asylum," recognized in the midd e ages as belonging to church buildings. It appears that the soldiers of General Hippolyte have not respected that right this time and they have forcibly taken from the Dominican and other consulates at Port-au-Prince political refugees who were shot immediately L'Ordreau, without adding to these ex-

ecutions or the violations of consular residences, speaks as follows: "There are people who imagine they are safe because they are in the consulates. Very good men, but how is it that persons who went out from a consulate in order to attack the jail have entered there again after the flight of their ac-complices! What is that right such people make use of and under what right do the consuls act as they do! Are the consulates a kind of fortress from which people can sally forth when they expect to win and to which they return as soon as they have lost the fight!! And L'Ordreau adds, "That will make the subject of another article." It is evident that this promised article will

be an arraignment of the asylum privileges enjoyed by the consulates, which was so powerful in mitigating the frequent revolu-tions in Hayti. In case the government of Hippolyte would dare to disrespect the consular privilege of asylum, which was always recognized, the foreign powers of Europe and America cannot fail to note and to assert by an uitimatum of an international character the right of their consuis to political

refugees.

The same Port-au-Prince paper attacks the defeated insurgents in a ferocious manner.

"The affair," it says, "did not last long, but its consequences have been bloody. They were what they ought to have been. We say no more about it. It is urgent that they should continue for some time longer. The actual government is on the defensive. is true for the private citizen is true for the government. When you kill in defending yourself you kill well—that is, you kill ac cording to all legal forms. The rebels wil be annihilated and also the party which they represent.' Then the paper lays all responsi-bility upon the head of Manigat, the exiled leader and the probable instigator of the troubles which caused, on May 31, the first proclamation of the state of siege at Port-au-Prince. "It is sufficient," says L'Ordreau, "to give the name of the high chief of the in-surgents to convince the republic that the revolutionists of Port-au-Prince are bandits of the worst kind. Legitimists, Piquantists, Priphatists, Canalists, nationals and liberals, even former Hipolytists have unanimously grouped themselves under the banner of S Surin Francois Manigat. But the name of Manigat has killed them. We say killed, be cause those who are not killed will soon be.'

INDICTED FOR LYNCHING.

True Bills Found Against Seven Soldiers at Walla Walla.

WALLA WALLA, Wash., June 10 .- The grand jury empanelled to investigate the lynching of Hunt by soldiers April 25 has reported to the superior court a true bill against seven enlisted men of the fourth United States cavairy. The report says there is no doubt Colonel Campton did not believe his troops would attempt to lynch Hunt, but the attack on the sheriff and his prisoner on the night before the lynching and the open defiance of the non-commissioned officers supported by the guard, should have been sufficient warning to him of what might be expected, and negligence existed in not tak-

ing ample precaution to keep his men under control. In the jury's opinion the sheriff was taken by surprise and was not prepared for defense, and that if he had made any resistance an alarm could have been sent out and assistance secured and in all probability the assistance secured and in an probability ine mob would have been dispersed without gaining its object. The jury suggests that the county commissioners prepare a state-ment of the expenses incurred by the county on account of the outrage and present the same against the United States. It is thought that as the relations between the citizens and troops are rather strained it would be well to have the latter exchanged.

BATTLE WITH STRIKERS. Grand Rapids Police Disperse a Mob

After a Fight. GRAND RAPIDS, Mich., June 10 .- The street car strike broke out again early this morning. A crowd of 200 gathered at the Sweet street cable station and were smashing things when a posse of police arrived. A pitched battic ensued. Revolvers were fired and bricks and sticks were thrown before the mob was dispersed. The officers arrested thirteen of the mob. On the other side is engraved what looks like a papal mitre and a stand of armor with cros el swords. FINANCIAL ASSISTANCE CALLED FOR.

Parnell Bitterly Denounced and Characterizi as a Man Utterly Unfit to Hold a Position of Trust.

New York, June 10. - Thomas Addis, M. D. president of the National Federation of America, has issued an address under date of June 9 "to the friends in America of nome rule for Ireland." It was in part as

From all in sympathy with the sufferings of the Irish people, due to centuries of misgovernment, and all who advocate home rule, the only reme ly to better their condition, we ask co-operation and assistance to bring about a consummation. The time has passed for inaction, and he who now hesitates to take part in what God grant may prove a final effort is either bindly ignorant and indifferent to passing evens or secretly sympathizes with those in opposition.

In our eneration the Irish people have suffered and almost lost their cause when success seemed within easy grasp. For months past every effort his been parilyzed through the acts of one man, the nost trusted of all, who sinned and fell by his own hand. He tims betrayed the welfare of his country, so blindly

sinned and fell by his own hand. He thus be-trayed the wolfare of his country, so blindly trusted to his guidance, and dragged the chaste name of Ireland into the gutter with his own sulled reputation. The necessity for assisting the starving and evicted tenants of Ireland was deeply approclated in this coun-try and a noble effort was made to effect the purpose. Mr. Parnell was fully pledged to carry out this object, but he has betrayed his trust by his duplicity, his equivocation and his utter disingenuousness. His continuous selfsh subordination of the welfare of the Irish peasantry to his own personal ends in the matter of home rule is no less conspicu-ous.

Mr. Parnell stands today responsible for the Mr. Parnell stands today responsible for the present sufferings of the evicted tenants of Ireland so far as they might have been mittigated by the use of the Paris fund, in the application of which he has refused to act with the other custodians. The fund consists of over \$200,000, the greater portion of which was raised in this country. This he now holds as he holds his political position—by false pretense. The people of this country are too sharp not to appreciate his purposes, and the fact that he did not carry out his own proposition when the opportunity was given him to meet his constituents at the polis has shown to the American mind how fully he realizes his desporate fortunes. He is yet claimed as a leader by a small portion of the Irish people. We raise no issue with them, nor doubt their honesty, but we happen their judgment. They will soon penetrate the great amour associated with the past service of an overrated leader.

rated leader.

Those who have worked and hoped for home rule in Ireland are not divided into two parties; there exists but one party and a faction. Mr. Parnell was the first to advocate that the majority should rule and the first to disregard the fact. The opinion held by the large majority of thinking men in this country, if expressed, would be to the effect that Mr. Parnell is now pelliteally dead and can never be resurrected to hold a position of trust. There was at first some difference of opinion as to the calpability of the act, as Irish-Americans were unwilling to interfere and wished the differences settled by the irish people themselves.
